**INVERCLYDE LICENSING BOARD**

**WEDNESDAY 26 OCTOBER 2022 AT 10.00 A.M.**

**Present:** Councillors Brooks, Cassidy, Jackson, Law, McCormick, McVey, Reynolds and Robertson.

**Chair:** Councillor Brooks presided.

**In attendance:** Ms Anne Sinclair, Fiona Denver and Emma Peacock (for Clerk to the Board); Sergeant Fiona Moore-McGrath (Police Scotland); and Crawford Brown (Licensing Standards Officer)

**Apologies:** There were no apologies.

**Declarations of Interest:** Councillor Brooks declared an interest in Agenda Item 2.1 Variation of Premises Licence Application

The meeting was held at the Municipal Buildings, Greenock with Councillors Jackson, Law and McCormick attending by video-conference.

Councillor Brooks declared an interest in Agenda Item 2.1 below, recused himself and left the Meeting. Councillor Reynolds took the Chair.

**LICENSING (SCOTLAND) ACT 2005

Councillor Brooks returned to the Chambers and resumed the Chair prior the next item.

**INVERCLYDE LICENSING BOARD FESTIVE SEASON POLICY 2022 – 2023**

There was submitted a report by the Clerk of the Board on the proposed terms of the Festive Season Policy 2022 – 2023. Ms Sinclair read the contents of an e-mail from Police Scotland dated 19 October 2022 which requested the Board consider (a) that the extended hours is utilised for events related specifically to the Festive Season; (b) that Licence Holders notify Police Scotland by 1 December 2022 if they intend to use it; and (c) consideration be given to changing the terminal hour to 3am Thursday to Saturday for Nightclubs.

Ms Sinclair confirmed that previous Festive Season Policies have stipulated that only events which relate to the festive season are applicable and that the nightclub premises currently operate the hours specified in the Festive Season Policy on a Friday and Saturday night.

Sergeant Moore-McGrath addressed the Board on the reasons for the request by Police Scotland.

Following discussion, the Chair moved grant of the Policy as outlined in Appendix 2 with the recommendations set out in 2.1(a)(ii) to (h) of the report which was unanimously agreed.

Decided:

- (a) that 'blanket' extensions under section 67 of the Act for licensed premises (except Off Sales) shall apply;

- (b) that the Festive Season Policy will cover the period from Friday 9 December 2022 to Monday 2 January 2023 inclusive;
- (c) that licensed premises (except nightclubs) may open until 1.00 a.m. on Sunday to Wednesday and 2.00 a.m. Thursday to Saturday and nightclubs may open until 2.00 a.m. on Sunday to Wednesday and 3.30 a.m. (Bar to close 3.00 a.m.) on Thursday to Saturday;
- (d) that the terminal hour on Sunday 25 December, Monday 26 December 2022 and Sunday 1 January and Monday 2 January 2022 has the same terminal hour as Thursday to Saturday;
- (e) that the event being held must relate to the festive season e.g. Christmas Party Night, Hogmanay, and not to Birthday Parties, Weddings etc.;
- (f) that the curfew of 12 Midnight on 31 December 2022 will be relaxed to 1.00 a.m.;
- (g) that to assist the administration process, licence holders should notify the Police Scotland Licensing Department as soon as possible of those dates within the Festive Season Policy they intend to utilise; and
- (h) that occasional licence applications made for non-licensed premises e.g. Greenock Town Hall, Gamble Halls, Port Glasgow Town Hall, Community Halls etc for an event within the festive period may have the same hours granted in terms of the Festive Season Policy for events solely related to festive activities.

### UPDATE REGARDING FUTURE DELIVERY OF LICENSING BOARD MEETINGS

There was submitted a report by the Clerk of the Board regarding the future delivery of Licensing Board meetings in light of new legislative change introduced by the Coronavirus (Recovery and Reform)(Scotland) Act 2022. Ms Sinclair, Depute Clerk, advised that the Board would require to review its current meeting arrangements and decide what arrangements should be in place in future to provide Licensing Board Members, Officers, applicants and any representatives with clarity.

Sergeant Moore-McGrath advised the Board that she covers two Licensing Boards and due to resource issues, attending face to face may be difficult especially if meetings fall on the same day, therefore having the option of a hybrid meeting makes it easier to manage.

Following discussion Councillor Brooks moved that meetings of the Licensing Board are held in person, proposed deletion of the remaining wording in bullet point 1 and that the other recommendations in the report in bullet points 2 -5 are accepted. As an amendment, Councillor McVey moved that all the recommendations (bullet points 1 – 5) are agreed in their entirety therefore providing the option of hybrid meetings being available. Following a roll call vote, one Member, Councillor Brooks voted for the motion and seven Members, Councillors Cassidy, Jackson, Law, McCormick, McVey, Reynolds and Robertson voted for the amendment which was declared carried.

Decided:

- (a) that meetings of the Licensing Board are all held on a hybrid basis moving forward, in accordance with Inverclyde Council's previously approved Remote and Hybrid Meeting Protocols, the exception to this being as agreed by the Council at its meeting on 23 September 2021;
- (b) that public attendance be facilitated by permitting physical attendance and extending an electronic invite to any member of the public who requests an invitation, with contact details to make such a request being published on each Calling Notice;

- (c) that, as under the current arrangements, given its *quasi-judicial* nature, the Licensing Board will adopt the position agreed by the Council, that such meetings shall not be live streamed, save where required by law;
- (d) that authority be delegated to the Clerk and Depute Clerk of the Licensing Board, in consultation with the Chair of the Licensing Board, to determine whether any Licensing Board meeting should instead be held on a fully in person or fully remote basis, where it is considered appropriate, for example, for reasons of public health; and
- (e) that authority be delegated to the Clerk and Depute Clerk of the Licensing Board, in consultation with the Chair of the Licensing Board, to determine the manner in which a hearing is held before the Licensing Board, in terms of the Coronavirus (Recovery and Reform) (Scotland) Act 2022.

### **BENCHMARKING EXERCISE ON THE INVERCLYDE LICENSING BOARD'S INCOME AND EXPENDITURE POSITION**

There was submitted a report by the Clerk of the Board. Ms Sinclair, Depute Clerk, addressed the Board providing an update in respect of the Board's income and expenditure position and how it compares to that incurred by other Licensing Boards.

Councillor Brooks noted that other Authorities also run on a deficit although some of the parameters are not the same.

Ms Sinclair confirmed that, on the instruction of the Chair, a letter was issued to the Scottish Government requesting an update regarding the review of occasional licence applications which had been undertaken by the Scottish Government in 2019. Ms Sinclair advised that the response received from the relevant Government Minister stated that there were no proposals to increase the level of fee for an occasional licence. A copy of the response will be circulated to Members.

Members unanimously agreed to note the contents of the report and that Ms Sinclair will make further enquiries of SOLAR's licensing group regarding the issue of the statutory level of fees for occasional licences.

### **REPORT REGARDING REMIT TO THE INVERCLYDE LICENSING BOARD REGARDING CONTROL THE BLEED KITS**

There was submitted a report by the Clerk to the Board on a remit from the Education & Communities Committee requesting that the Board consider whether it is appropriate to attach a condition or recommendation to a Premises Licence that each licensed premises in Inverclyde should have a Control the Bleed Kit upon their premises. Ms Sinclair, Depute Clerk, addressed the Board and advised of the restrictions upon the Licensing Board, in that additional licensing conditions can only be attached in circumstances relating to licensing objectives. Ms Sinclair highlighted that the Board may wish to consider including this matter as part of the Board's review of the Licensing Board Policy consultation.

Following discussion, Councillor Brooks moved to agree the recommendations in the report which was unanimously agreed.

Decided:

1. that Control the Bleed Kits form part of the public consultation on the Licensing Board's Policy Statement which is due to be reviewed by 31 October 2023; and
2. that the Clerk of the Licensing Board shall write to all licensed premises in Inverclyde with a recommendation that licensed premises should acquire and have a Control the Bleed Kit on their premises.

**REMIT TO THE INVERCLYDE LICENSING BOARD REGARDING “GET ME HOME SAFELY”  
CAMPAIGN OF UNITE THE UNION**

There was submitted a report by the Clerk of the Board asking the Board to consider a request from Councillor Cassidy that the Board should consider the most appropriate approach to the above campaign. Ms Sinclair addressed the Board on the lack of options available in terms of the legislation in relation to adding a condition to a premises licence, however explained that the Board may wish to consider including this matter as part of the review of the Board’s Policy consultation.

Following discussion it was unanimously agreed that the “Get Me Home Safely” Campaign would form part of the public consultation on the Licensing Board’s Policy Statement which is due to be reviewed by 31 October 2023.

### 3.0 BACKGROUND AND CONTEXT

3.1 Section 12(a) of the Licensing (Scotland) Act 2005 (the 2005 Act) requires the Chief Constable of Police Scotland to prepare a report for the Licensing Board setting out:

- (a) The Chief Constable's views about the matters relating to policing in connection with the operation of the 2005 Act in the Board's area during that year and the following year:
- (b) Any steps the Chief Constable:
  - (i) has taken during that year;
  - (ii) plans to take in the following year;

to prevent the sale or supply of alcohol to children and young persons in that area.

(c) The Chief Constable is then required, as soon as practicable after the end of each relevant financial year, to send that report to the relevant Licensing Board. The Chief Constable has now submitted the Inverclyde Annual Licensing report for the period 1 April 2021 – 31 March 2022 which is set out in **Appendix 1** to this report.

### 4.0 PROPOSALS

4.1 As the report is included in full at **Appendix 1**, its terms are not repeated within this covering report.

4.2 Members are asked to note the key points from the report which include:

- (1) Joint working during the reporting period is referenced between Police Scotland and various agencies, including the Board's Licensing Standards Officer.
- (2) During the reporting period, Police Scotland has not objected to or made representations in respect of the grant of any new premises licence application made to the Board.
- (3) During the reporting period, Police Scotland provided two submissions in respect of Personal Licence Holders to the Board.
- (4) Partnership working will continue to be a key feature going forward with the report emphasising the importance of this collaboration for all agencies in seeking to promote the licensing objectives.

4.3 A breakdown of relevant statistics for the Inverclyde area is included within Appendix A to the Chief Constable's report. Information concerning the number of relevant crimes within the relevant reporting period are set out in Appendix B to the Chief Constable's report.

4.4 The report sets out that during the relevant reporting period there were 205 licensed premises in Inverclyde, 79 were licensed for off-sales only, 71 for on-sales only and 55 were licensed for both on and off sales.

4.5 The report sets out that Police Scotland has three levels for categorising licensed premises that come to their attention, Monitored, Intervention and Problem premises.

4.6 The Chief Constable's report sets out that there were a total of 4 premises within Inverclyde which were monitored and subject to regular inspection during the relevant reporting period.

4.7 Figures for the number of crimes and offences committed within the Inverclyde Board area for the reporting period from 1 April 2022 – 31 March 2022 are set out in Appendix B of the Chief

Constable's Report. The total number of offences under the 2005 Act in the Inverclyde Board area fell from 6 in the period 2020-2021 to 1 in the period 2021-2022. This reduction is believed to be attributed to Covid restrictions.

- 4.8 The report also sets out Police Scotland's local policy initiatives and campaigns such as "Don't Ask for It ", "I Am Me ", and the "Pitchin In Programme" together the work carried out by the Inverclyde Partnership Hub in tackling anti-social behaviour, violence and drug related deaths.
- 4.9 A representative of Police Scotland will be in attendance at the Board meeting on 1 December 2022 to present the Chief Constable's report and answer any questions members of the Board may have.

## **Police Scotland Licensing Overview –**

The Violence Prevention and Licensing Co-ordination Unit (VPLCU) sits within Safer Communities based at Dalnarnock Police Station, Glasgow.

The VPLCU upholds the two tier structure for licensing which supports both national and local priorities through service delivery. They have overall responsibility for determining and delivering national licensing strategy and policy, by providing advice, guidance and support to divisional licensing teams as well as undertaking other specialist functions.

The Violence Prevention and Licensing Co-ordination Unit is a specialist department which consists of a small team of officers, based in Glasgow. The officers within the unit work with divisional licensing teams and partner agencies to help shape policy and strategy around the police licensing function. They provide practical and tactical advice to police licensing practitioners, operational officers, supervisors and policing commanders.

The VPLCU seek to ensure that legislation governing the sale and supply of alcohol is applied consistently across the country and all opportunities are taken to stop the illegal or irresponsible sale, supply or consumption of alcohol with the intention of preventing and reducing crime and disorder.

During 2021/2022, from a licensing perspective, our particular focus was on the following;

- Scrutiny of the serious incidents of violence, disorder and antisocial behaviour linked to licensed premises.
- Working closely with Licenced Premises and Scottish Government to navigate the challenges of the COVID-19 pandemic through the 4Es approach by engaging, explaining, educating and enforcing.
- Governance and ongoing development of the National ICT Licensing System, known as “Inn Keeper”, to increase the efficiency and effectiveness of liquor and civic licensing administration and management. Police Scotland are currently working on upgrade to the National ICT system to ensure compliance with GDPR legislation.

Each of the 13 Local Policing Divisions have a licensing team responsible for the day to day management of licensing administration, complying with statutory requirements as well as addressing any issues that may arise within licensed premises in their local area.

## **LICENSING BOARD AREA**

The Licensing Board area is policed by Renfrewshire and Inverclyde Division.

Chief Superintendent David Duncan is the Divisional Commander with responsibility for all policing functions.

Chief Inspector Paul Cameron is the Local Area Commander for Inverclyde with responsibility for the management of personnel, local service delivery, community engagement and partnership working to ensure local and national priorities are met during the reporting period.

Inverclyde is bordered to the north/west by the Firth of Clyde, the east by Renfrewshire and stretches south where it meets North Ayrshire. It has a population of over 80,000 people. It is one of the smallest in terms of area (29th) and population (27th) of the 32 Scottish unitary authorities.

**NOT PROTECTIVELY MARKED**

The main population centres of Greenock, Port Glasgow and Gourock are surrounded by smaller local communities such as Wemyss Bay, Inverkip and Kilmacolm and policing delivery is tailored to meet the needs of those communities. Partnership working in Inverclyde is well established and those partnerships deliver a highly effective police service which has a positive impact on local communities.

Inverclyde has a rich and renowned history in shipbuilding and the 'deep water docking' on the Clyde offers berth to visiting cruise ships. Much investment has

Been made in education within Inverclyde with the area being home to the Greenock campus of West College Scotland.

There are currently 205 licensed premises in Inverclyde, 79 are licensed for off sales only, 71 on sales only and 55 for both on and off sales.

**Local Policing Priorities**

Following our public consultation process, the policing priorities for Inverclyde

Division, as set out in our Local Policing Plan are as follows;

- Protecting people at risk of Harm
- Serious and Organised Crime
- Violence, Antisocial Behaviour and Disorder
- Road Safety and Road Crime
- Counter Terrorism and Domestic Extremism
- Acquisitive Crime
- Cyber and Digital Crime

## **OPERATION OF THE LICENSING (SCOTLAND) ACT 2005**

Alcohol misuse, exacerbated by its accessibility, availability and affordability, is commonly acknowledged as a contributory factor in incidents of violence, disorder and antisocial behaviour.

Police Scotland continues to work with its partner agencies, including the licensed trade, to reduce the impact alcohol misuse has on local communities. By working together we can target those who fail or simply refuse to promote responsible trading practices. Together we can improve the safety and wellbeing of people, places and communities in Scotland.

Police Scotland currently have 3 levels for categorising licensed premises that come to our attention:

- **Monitored** – Premises that require extra support and supervision. This can include premises coming to police attention through incidents or newly opened premises with inexperienced staff. A low key approach is used to address issues before they escalate.
- **Intervention** – A formal intervention agreement is put in place to improve the safe and legitimate operation of a premises. This intervention plan, which contains a list of conditions, is agreed between all parties. The intervention period would last a minimum of three months and be subject to review.
- **Problematic** – Premises deemed problematic will normally be the subject of a premises licence review submission by Police Scotland to the Licensing Board.

Any categorised premises will be subject to regular inspections to ensure compliance and will form part of the tasking regime for the night time economy action plans. All inspections, pro-active, re-active or planned are submitted via the Innkeeper system.

Figures for the period 1<sup>st</sup> April 2021 to 31<sup>st</sup> March 2022 show that there were a total of 4 premises within Inverclyde which were monitored and subject to regular inspections. There were no premises subject of a premises review.

## **Summary**

Appendices A and B provide details of all crimes/offences detected within Renfrewshire and the volume of applications processed by Police Scotland for licensed premises within Renfrewshire in terms of the Licensing (Scotland) Act 2005, between 1 April 2021 and 31 March 2022.

**Section 1 – Unlicensed sale of alcohol** – There were no offences of this nature reported.

**Section 22 – Objections and Representations** – No representations were submitted by Police Scotland in response to the grant of new premises licences.

**Section 36 – Review Applications** – One premise was subject to a review application.

**Section 63 – Sale or supply out-with licensed hours** – There were no offences of this nature reported.

**Section 72 – Personal Licence Applications** – Two submissions was made to the Licensing Board during the period.

**Section 82 – Failure to notify Licensing Board of convictions** – No persons were charged for failing to disclose convictions to Board.

**Section 84 – Personal Licence Reviews** – One individual was subject of a personal licence review.

**Section 94 – Exclusion Orders** – There were no exclusion orders.

**Section 97 – Closure Orders** – There have been no closure orders issued.

**Section 104 – Buy/attempt to buy alcohol on behalf of a child** - No individuals were charged for committing this offence during the period.

**Section 108 – Deliver alcohol to person under the age of 18** – No persons were charged for committing this offence during the period.

**Section 111-116 – Drunkenness/Disorder Offences** - One person was charged under these sections during this period.

**The total number of offences recorded under the Licensing (Scotland) Act 2005 within Inverclyde has fallen from 6 in 2020-2021 to 1 in 2021-2022, the reduction is believed to be attributed to the Covid restrictions during this period.**

## **PREVENTING THE SALE OR SUPPLY OF ALCOHOL TO CHILDREN OR YOUNG PEOPLE**

### Partnerships

Partnership working is key to delivering tangible outcomes and we continue to strengthen our relationships with all agencies, community representatives and local residents to ensure our services are co-ordinated, effective and efficient and address the needs of our communities.

### **DON'T ASK FOR IT - Proxy Purchase Campaign**

This Campaign focused on hot spot areas with Educational interventions supported by third sector partners.

The main aims of the campaign were to

- Reduce the number of attempted purchases of alcohol for under 18s.
- Reduce crime and antisocial behaviour in the area.
- Reduce the vulnerability of those abusing alcohol under 18.
- Reduce the number of hospital admissions for under 18s with alcohol related injuries.
- Educate the public regarding the offence and dangers of proxy purchase within our communities.
- Educate Off-Sales and Licensed Premises to highlight the dangers of Proxy Purchase and operate within the Licensing Objectives.

The success of initiatives such as “Challenge 25” and joint work with Renfrewshire Council have reduced the direct sale of alcohol to those under 18, however alcohol related violence and anti-social behaviour illustrate that younger age groups are increasingly gaining access to alcohol by other proxy sales. The most common method involves asking adults to buy alcohol for them.

The Licensing (Scotland) Act 2005 makes it an offence for a person to act as an agent for a child in purchasing or attempting to purchase alcohol’. This is known as proxy purchase. The penalties for this offence include a fine of up to £5000 and/or three months in prison.

Further social media campaigns were run highlighting the campaign however due to the ongoing pandemic and Covid restrictions very little face to face engagement was able to be carried out.

The proxy purchase campaign is soon to be replaced by “IT’LL COST YOU” which will launch in the coming weeks and will involve engagement and partnership working with the major retailers and relevant partners.

### **“I am Me”**

Renfrewshire and Inverclyde Division works in partnership with “I Am Me” providing a network of local businesses to create ‘Keep Safe’ places for disabled, vulnerable, and elderly people. There are currently 156 Keep Safe places in the Division, 19 of them are licensed premises. The Keep Safe Ambassador Programme has continued in the Division and now has 114 High School Ambassadors which has more than doubled from the previous year, 12 Police Scotland Youth Volunteer Ambassadors, 40 Ambassadors with a learning disability and 9 Keep Safe Ambassador trainers across the Division. This provides vulnerable sections of the community areas where they can safely report crime. Such areas have been set up in the central business district where there is a higher proportion of on/off sales premises.

Please note the reduction in licensed premises as Keep Safe places, believed to be attributed to some premises not reopening following Covid restrictions.

### **Pitchin In Programme**

The Pitchin’ In Programme was developed by Police Scotland and Glasgow City Council in 2014-15 following a largescale incident of disorder involving young football supporters during which those involved put their own personal safety, and the safety of others, at risk. The Pitchin’ in Programme can be used proactively to assist young people to develop their decision making skills to help them avoid being drawn into harmful behaviour, with the Programme being delivered in schools, colleges and in conjunction with club community trusts. Where individuals have already been charged with criminal offences, the Pitchin’ in Programme can be used as a swift response, providing a constructive alternative to prosecution by harnessing the individuals’ positive links with their chosen football club.

During the reporting period Community Officers in Inverclyde have delivered this to a group of pupils from [REDACTED] who have been identified as requiring support. This will be ongoing throughout the school year and thus far has been well received with positive links being formed.

### **Inverclyde Partnership Hub**

In 2021 Inverclyde Partnership Hub was formed and implemented by Police Scotland to operate within Greenock Police Office. It was developed utilising good working practices adopted from elsewhere and tailored to operate in Inverclyde, building on strong partnership foundations already established. The aim of the Inverclyde Community Partnership Hub is to work with partners on a daily basis to tackle anti-social behaviour, violence, drug related deaths and identify vulnerability in Inverclyde by co-ordinating all partners in an efficient structured and cohesive manner.

The structure used ensures that the daily tasking and risk incidents are focused, relevant and with clearly identified areas of ownership.

**NOT PROTECTIVELY MARKED**

Each meeting involves a review of Police, Fire, Community Warden or other significant incidents or events over the previous 24-hour period. Information is pro-actively disclosed to partners who attend the daily meetings where reasonable, appropriate, proportionate and lawful to do so for effective and early intervention. Key to the development of the Inverclyde Partnership Hub has been full engagement and inclusion of key partners who have a responsibility for protection and wellbeing of our communities.

The following key partners are currently fully engaged in the Partnership Hub however there is more room to expand as necessity dictates.

**Take Five Scam Awareness**

In response to the escalating reports of on-line and telephone scams Police Scotland, Trading standards and Inverclyde Council funded Take 5 campaign and Illegal money lending advice leaflets to be included within all 2022 council tax notices. This will reach nearly 40,000 homes across Inverclyde and will provide some simple and easy to follow, effective advice about how to prevent yourself from becoming a victim of financial crime.

**Fearless Link**

Fearless is an extension Crimestoppers aimed at supporting young people and specifically developed to overcome the hurdle of “grassing” mentality by highlighting the benefits of being independent from Police, and allows for anonymous reporting to help fill the intelligence gaps both within the community and in education environments. As part of the promotion of Fearless within Inverclyde Police and Education Authority worked together to embed the Fearless link into Glow education platform. This gives easier direct access to Fearless website which provided useful information on crime trends and reporting mechanisms for all school pupils across Inverclyde.



## **TACKLING SERIOUS AND ORGANISED CRIME**

The Serious Organised Crime Taskforce was set up to ensure Scotland can respond robustly to the threat posed by organised crime, identify improvements, and ensure all agencies are working to the same aims to raise public awareness. Membership of the group includes the Solicitor General; the Police Service of Scotland; the Prison Service; Her Majesty's Revenue and Customs (HMRC); National Crime Agency (NCA); Society of Local Authority Chief Executives (SOLACE); Her Majesty's Inspectorate of Constabulary Scotland (HMICS) and Scottish Business Resilience Centre (SBRC).

Its remit is to work together to help deliver the Scottish Government's commitment to tackling serious organised crime by:

- Identifying priorities for tackling serious organised crime (SOC) in Scotland.
- Sharing best practice and improving co-ordination between law enforcement agencies and others;
- Identifying innovative ways of working together and encouraging better ways of working together;
- Developing a coherent Scottish response on reserved and other SOC issues; and
- Making proposals for legislation, research and other measures to tackle SOC.

There are several groups operating within the Renfrewshire area, some of which have connections to the licensed trade, via licensed premises, second hand dealers, tanning salons and car wash facilities. Police Scotland, in conjunction with our partner agencies, have identified innovative ways to disrupt such organisations who are targeted through multi-agency days of action. Whilst it can be difficult to link these groups to serious crimes, targeting other crimes has proven to be a useful tool in disrupting their operations.

Further recruitment of young people will ensure these operations continue to be carried out by Police Scotland throughout 2021 and 2022.

**Enforcement Operations**

The Licensing department will continue to plan and co-ordinate multi agency operations with officers from Home Office Immigration Enforcement (HOIE), Her Majesty's Revenue and Customs (HMRC) and Renfrewshire Council targeting all forms of licensed premises and persons within the area.
