Ms Sinclair advised that Police Scotland had submitted an objection to the application and read the letter of objection dated 29 November 2022 to the Board, copies of which had previously been circulated to Members.

Mr McGowan addressed the Board and spoke on each of the issues raised by Police Scotland. He outlined the history of the similar applications which had been considered by the Board.

Inspector Christie addressed the Board on the Chief Superintendent's objection and points raised by Mr McGowan.

There followed questions and answers from all parties, during which Mr McGowan confirmed that the application in respect of 25 December be withdrawn from the application and that the bar would close at 2.30 a.m. on Tuesdays 20 and 27 December 2022.

After discussion, Councillor Robertson moved grant of the application, as amended which was unanimously agreed.
