ADDITIONAL ITEM

The Chair intimated that the Board had been asked to consider an additional item which he proposed to consider at this juncture, prior to hearing the next two items which could be taken together. Members agreed to the Chair's request.

Ms Sinclair advised that the additional item is in relation to an occasional licence application by Royal Gourock Yacht Club in respect of which two public objections had been received. The application is for a Disco/Dance event to be held on the balcony of the Club on 10 June from 2.00 p.m. – 10.00 p.m.

One objector, Ms Murdoch had submitted her apologies that she was unable to attend the meeting. Neither objector was in attendance.

Mr Doug Haldane, Honorary Secretary, Charles Webster and Bruce Glenny Event Organisers were present.

Ms Sinclair read the contents of each objection to the Board which referred mainly to noise levels and traffic problems.

Sergeant Robertson confirmed Police Scotland has no objection to the application.

Ms Dillon advised that having checked Council records, there have been no noise complaints reported previously and the premises have held similar events in the past which were not the subject of noise complaints. She considered that the terminal hour of 10.00 p.m. is not unreasonable. Ms Dillon intimated that in relation to the traffic issue, there are double yellow lines in the area.

Ms Sinclair advised Members that traffic management is an irrelevant consideration in licensing matters.

Mr Haldane addressed the Board stating that the disco/dance event had been held last year and the music finished at 9.30 p.m. He had no comment to make on the parking issues. Mr Haldane advised that the event is important to the Club, it is not a routine event, and only one event of this kind is planned this year, albeit they will hold one more similar event. Mr Haldane also clarified that being fully aware of the complaints that notices will be displayed around and outside the premises advising of noise levels.

There followed questions form Members which Mr Haldane responded to. Mr Webster provided further information on the organisation of the event including ticket sales. He advised that (i) no tables and chairs would be located on the roadside; (ii) no person under the age of 21 is admitted; (lii) professional stewards will be in place, (iv) last orders at the bar will be 9.15 p.m.; (v) the premises will be cleared at 10.00 p.m.; (vi) a varied selection of music will be played; and (vii) the sound levels will be monitored. Mr Webster stated that a number of residents were in support and attending the event and it will run as an exact carbon copy of last year's event which passed without any problem.

Councillor Robertson moved grant of the application which was unanimously agreed.

In attendance: Ms Anne Sinclair and Fiona Denver (for Clerk to the Board), Inspector Joanne Henderson and Sergeant Iain Robertson (Police Scotland), Roisin Dillon (Public Protection Team Lead) and Crawford Brown (Licensing Standards Officer).

Apologies and Declarations of Interest: There were no apologies or declarations of interest intimated.

The meeting was held in the Council Chambers, Municipal Buildings with Councillors Jackson, McCormick and Law attending remotely.

1. Licensing (Scotland) Act 2005: Finance and Function Reports

The Depute Clerk presented the Annual Finance report, with income and expenditure figures, and the Annual Functions report for the period April 2022 until March 2023, and explained that both reports require to be published on the Licensing Board's website by 30 June 2023 to comply with the Licensing (Scotland) Act 2005. In relation to the Annual Finance report, the Depute Clerk highlighted the higher level of income in the last year in relation to liquor licensing fees. The Depute Clerk explained that this is a reflection on the increase in the number of applications received, particularly occasional licence applications, to facilitate outdoor drinking under the Board's previous outdoor drinking policy for the duration of the pandemic until 30 September 2022 and thereafter to facilitate outdoor drinking pending applications for major variation of premises licences. Following questions and a discussion the Members unanimously approved both the Annual Finance report and the Annual Functions report for 2022 to 2023.

2. Licensing (Scotland) Act 2005: Licensing Board Policy Statement Review

The Depute Clerk updated members on the outcome of the initial consultation in relation to the review of the Board's Licensing Policy Statement. The Depute Clerk reminded members that the Licensing Board's reviewed Policy Statement requires to be published within 18 months of the Local Government Elections which were held on 5 May 2022 and therefore no later than 4 November 2023. In particular, Ms Sinclair summarised the results of the 65 responses received in relation to the online consultation in Appendix 1 of the report, the response of Police Scotland, set out in Appendix 2 and the joint response of Inverclyde HSCP/Greater Glasgow & Clyde Health Board in Appendix 3, with health statistics in relation to the 17 intermediate zones in Inverclyde.

The Chair, Councillor Brooks, advised members that the Licensing Board Policy Statement requires input from the Local Licensing Forum and it would be helpful that the Board heard from the Forum in advance of considering what revisals were appropriate to the Policy. Cllr Brooks considered that it would be helpful if Members could have a timeline in relation to review of the policy.

Inspector Henderson confirmed that she had nothing further to add to the written submission on behalf of Police Scotland. The Chair also asked Roisin Dillon, Public Health Protection Manager, if she had anything further to add. She advised that she had no contribution at this time.

Thereafter the Chair invited Members to ask questions of Inspector Henderson or the Depute Clerk. Councillor McVey referring to the Curfew which is currently in place in Inverclyde asked Police Scotland what evidence existed to justify treating Inverclyde differently to other Licensing Board areas in Scotland, commenting that Inverclyde is the only Licensing Board area with such a curfew. Inspector Henderson explained that the response had been submitted by Sergeant Robertson who was currently attending the General Purposes Board and he intended joining the Licensing Board once the General Purposes Board had concluded.

In relation to the issue of over-provision, Cllr McVey expressed the view that the health statistics provided by Dr Daniel Carter are quite shocking and it is clear the Licensing Board requires to consider the issue of over-provision. Councillor McVey asked if it would be possible to differentiate between on and off-sales as one of the consultation responses mentioned that there were three off-sales within close proximity to each other. Ms Sinclair explained that it would be possible to differentiate and if there was an over-provision policy there would then be a rebuttable presumption that any new application would be refused. This policy would require to be applied consistently.

Councillor Robertson outlined two main areas of concern, in relation to the Curfew and the issue of over-provision.

Councillor Robertson explained she had been a member of an earlier Licensing Board which considered and decided to retain the Curfew. Councillor Robertson advised that at that time the Licensing Board Members followed the recommendation of Police Scotland that the curfew was useful in relation to the licensing objectives of preventing crime and disorder, securing public safety and preventing public nuisance. Accordingly, she considered that it was necessary that the Board has evidence before it from Police Scotland in relation to any proposed continuation of the curfew.

Councillor Robertson also stated that she would expect a report from the Licensing Forum to be made available in order to inform any decision of the Licensing Board in relation to overprovision. She expressed an initial view that over-provision has not been effective in the past. She considered that this was something which could be explored further during the joint session with the Licensing Forum . Councillor Robertson considered that it would be helpful to have additional information from Police Scotland available at the time of the joint meeting with the Invercelyde Licensing Forum.

Thereafter Councillor Jackson addressed Members of the Board on the issue of over-provision. He said that it seemed to him that in the past commercial interests always overruled health interests. Councillor Jackson acknowledged that it was important that any decision was evidence based, but stated that he would like to carefully consider over-provision in light of the health issues.

Thereafter Members heard from Roisin Dillon, Public Protection Manager. With reference to the recent Local Licensing Forum meeting she had attended, Roisin Dillon explained that there had been an indepth conversation around the health data provided by Dr Daniel Carter. There was a discussion about linking data with areas of over-provision but in her view there is no concrete evidence available that those areas with the worst health statistics are areas where alcohol is being purchased. Roisin Dillon gave the example of Kilmacolm, a low provision area for alcohol, and stated that this demonstrates that residents are not purchasing their alcohol locally.

Ms Dillon also stated that deciding what localities to use for the purpose of overprovision is difficult. She spoke about the difficulty with the current statistics, in her view a lot of the information is weighted as a result of the Covid Pandemic.

The Chair pointed out that one of the objectives of the Licensing Board is to improve public health and the Board requires to consider any evidence based proof.

Thereafter the Board Members discussed a potential review of the Board's policy regarding children and young persons. The current provisions are set out in page 16 of the existing report and reflect that children and young persons shall be accompanied and supervised by a suitable adult or adults when they are in licensed premises with children and young persons permitted in licensed premises until 8pm and permitted in licensed premises between 8pm and 11pm while they are accompanied by an adult and having a meal. Councillor Robertson highlighted that this has previously caused difficulty in relation to applications which have come before the Board. She requested that officers look at the way in which other Licensing Board's deal with the management of children and young persons on licensed premises.

(Councillors Cassidy and Reynolds had left the Licensing Board at 10am in order to join the General Purposes Board. They both re-joined the Licensing Board, as it was not considering any quasi-judicial matter, at 11.05am at which point the Depute Clerk provided them with a summary of the discussion thus far in relation to the Licensing Board Policy Review).

Sergeant Robertson also joined the Licensing Board meeting at this point.

Sergeant Robertson was asked about Councillor Robertson's question concerning the Curfew and what statistical information was available in order to support this. Sergeant Robertson confirmed he thought that the statistics could be made available for a future meeting. He stated that he does not recall being asked previously to comment on evidence to support the curfew. He thought the curfew was in place prior to commencement of Police Scotland and therefore in existence from the days of Strathclyde Police Force. He said he had previously spoken to Licensed Premises owners and they were supportive of retaining the Curfew because it helps retain business. Councillor Robertson pointed out that the Licensing Board must have had clear evidence before it in relation to the Curfew, linked to the licensing objectives when the decision was made to retain the curfew in 2018.

Councillor McVey requested a report on the legislation concerning alcohol deliveries, he raised concerns about the sale of alcohol on apps and fears that children are buying alcohol in this way.

Ms Sinclair provided advice that the use of apps to obtain alcohol deliveries was a modern phenomenon and was not provided for in the licensing legislation. However, officers would be able to prepare a report in relation to legislation around alcohol deliveries.

Thereafter there was a discussion in relation to the invitation which has been extended to **Unite the Union** in order to give a presentation to the Licensing Board regarding the Home Safer Campaign. Ms Sinclair highlighted that this was an outstanding remit from an earlier Licensing Board, and it was agreed that this matter would be considered as part of the review of the Licensing Board Policy Statement. Ms Sinclair confirmed that arrangements were being made for the presentation, which ideally will take place at the joint meeting of the Licensing Board and Licensing Forum which is being arranged. Following the discussion Members unanimously decided:

- (1) That the outcome of the initial consultation regarding review of the Licensing Board Policy Statement be noted, and no revisals be made to the existing policy at this point in light of the consultation responses;
- (2) Agreed the approach in relation to determining localities as set out in section 6.9 of the report, that is, the Board determined that there are 17 localities replicating the 17 Intermediate zones in the Licensing Board area; and
- (3) that a report should be brought to a joint meeting of the Inverclyde Licensing Board and Licensing Forum with relevant data in relation to each of the 17 localities/intermediate zones including mapping and confirmation of the number of licensed premises in each locality/intermediate zone.

Presentation by Representatives of Unite on the Get Me Home Safely Campaign

The Board heard a presentation on the Get Me Home Safely campaign given by Irina Do Carmo and Stephen Pinder of the Unite Trade Union. The campaign addresses the workplace safety issues faced primarily by women and aims to tackle gender-based violence by developing a host of solutions and extending the duty of care of employers of late-night workers to ensuring that they get home safely. Thereafter members discussed and considered the premise of the campaign in so far as it relates to the licensing objectives, and thereafter Ms Do Carmo, Mr Pinder and Ms Sinclair answered a number of questions from members.

Decided: that the presentation be noted.

Inverclyde Licensing Board Policy Statement Review

There was submitted a report by the Clerk to the Licensing Board providing additional information to members of the Licensing Board and Forum to assist in their discussion regarding a review of the Licensing Board's Policy Statement. The Policy Statement requires to be published within 18 months of the Local Government Elections on 5 May 2022 and therefore no later than 4 November 2023.

Ms Sinclair provided members with a provisional timescale for consideration of the Policy Statement before publication, with an informal private meeting of the Licensing Board by mid-August and a formal public meeting of the Licensing Board by the end of the month. Thereafter the Policy Statement would go out for consultation. Ms Sinclair advised that this would be a further opportunity for Forum members to submit their views in writing.

Mr Rebecchi questioned if the times given in the 'Alcohol deliveries' section of the report at paragraph 6.10 were correct, and Ms Sinclair advised she would consider this further and update members accordingly.

3.0 BACKGROUND AND CONTEXT

- 3.1 Section 12(a) of the Licensing (Scotland) Act 2005 (the 2005 Act) requires the Chief Constable of Police Scotland to prepare a report for the Licensing Board setting out:
- (a) The Chief Constable's views about the matters relating to policing in connection with the operation of the 2005 Act in the Board's area during that year and the following year:
- (b) Any steps the Chief Constable:
 - (i) has taken during that year;
 - (ii) plans to take in the following year;

to prevent the sale or supply of alcohol to children and young persons in that area.

(c) The Chief Constable is then required, as soon as practicable after the end of each relevant financial year, to send that report to the relevant Licensing Board. The Chief Constable has now submitted the Inverclyde Annual Licensing report for the period 1 April 2022 – 31 March 2023 which is set out in **Appendix 1** to this report.

4.0 PROPOSALS

- 4.1 As the report is included in full at **Appendix 1**, its terms are not repeated within this covering report.
- 4.2 Members are asked to note the key points from the report which include:
 - (1) Joint working during the reporting period is referenced between Police Scotland and various agencies, including the Board's Licensing Standards Officer.
 - (2) During the reporting period, Police Scotland has not objected to or made representations in respect of the grant of any new premises licence application made to the Board.
 - (3) During the reporting period, Police Scotland provided one submission in respect of a Personal Licence Holder to the Board.
 - (4) No person was the subject of a personal licence review. One licensed premises was subject to a review application.
 - (5) Partnership working will continue to be a key feature going forward with the report emphasising the importance of this collaboration for all agencies in seeking to promote the licensing objectives.
- 4.3 A breakdown of relevant statistics for the Inverclyde area is included within Appendix A to the Chief Constable's report.
- 4.4 The report sets out that during the relevant reporting period there were 198 licensed premises in Inverclyde, 73 were licensed for off-sales only, 71 for on-sales only and 54 were licensed for both on and off sales.
- 4.5 The report sets out that Police Scotland has three levels for categorising licensed premises that come to their attention, Monitored, Intervention and Problem premises.
- 4.6 The Chief Constable's report sets out that there were a total of 5 premises within Inverclyde which were monitored and subject to regular inspection during the relevant reporting period.
- 4.7 The report also sets out Police Scotland's local policy initiatives and campaigns such as "It'll Cost You Proxy Purchase Campaign "and I Am Me "together the work carried out by the Inverclyde Partnership Hub in tackling anti-social behaviour, violence and drug related deaths.

4.8 A representative of Police Scotland will be in attendance at the Board meeting on 7 September 2023 to present the Chief Constable's report and answer any questions members of the Board may have.

This collaborative working is vital to ensuring a fair and consistent approach to licensing while focussing on preventing alcohol fuelled violence, disorder and antisocial behaviour.

In the year ahead our approach will remain focused on prevention and collaboration to ensure efficient and effective service delivery. I will continue to encourage officers and staff to utilise the range of options available to improve licensing standards, reduce violence and to positively influence behaviour and attitudes across Scotland.

I would like to take this opportunity to thank our local partnerships and acknowledge their contribution in continuing to drive improvements with the Licensed Trade, and for the communities we all serve.

Police Scotland Licensing Overview -

The Violence Prevention and Licensing Co-ordination Unit (VPLCU) sits within

Partnerships Prevention & Community Wellbeing based at Dalmarnock Police Station, Glasgow.

The VPLCU upholds the two tier structure for licensing which supports both national and local priorities through service delivery. They have overall responsibility for determining and delivering national licensing strategy and policy, by providing advice, guidance and support to divisional licensing teams as well as undertaking other specialist functions.

The Violence Prevention and Licensing Co-ordination Unit is a specialist department which consists of a small team of officers, based in Glasgow. The officers within the unit work with divisional licensing teams and partner agencies to help shape policy and strategy around the police licensing function. They provide practical and tactical advice to police licensing practitioners, operational officers, supervisors and policing commanders.

The VPLCU seek to ensure that legislation governing the sale and supply of alcohol is applied consistently across the country and all opportunities are taken to stop the illegal or irresponsible sale, supply or consumption of alcohol with the intention of preventing and reducing crime and disorder.

During 2022/2023, from a licensing perspective, our particular focus was on the following;

- Scrutiny of the serious incidents of violence, disorder and antisocial behaviour linked to licensed premises.
- Governance and ongoing development of the National ICT Licensing System, known as "Inn Keeper", to increase the efficiency and effectiveness of liquor and civic licensing administration and management. Police Scotland are currently working on upgrade to the National ICT system to ensure compliance with GDPR legislation.

Each of the 13 Local Policing Divisions have a licensing team responsible for the day to day management of licensing administration, complying with statutory requirements as well as addressing any issues that may arise within licensed premises in their local area.

LICENSING BOARD AREA

The Licensing Board area is policed by Renfrewshire and Inverclyde (K) Division

Chief Superintendent Laura Waddell is the Local Police Commander who has the responsibility for all day-to-day policing functions.

Local Policing Priorities

Following our public consultation process, the policing priorities for Renfrewshire and Inverclyde Division, as set out in our Local Policing Plan are as follows;

- Cyber and Digital Crime
- Serious and Organised Crime
- Counter Terrorism and Domestic Extremism
- Antisocial behaviour, violence and disorder
- Road Safety and Road Crime
- Protecting vulnerable People
- Acquisitive Crime

The Licensing Board area is policed by Renfrewshire & Inverclyde Division

Chief Superintendent Laura Waddell is the Local Police Commander with responsibility for all policing functions.

Chief Inspector Damian Kane is the Local Area Commander for Invercive with responsibility for the management of personnel, local service delivery, community engagement and partnership working to ensure local and national priorities are met for the reporting period.

Inverclyde is bordered to the north/west by the Firth of Clyde, the east by Renfrewshire and stretches south where it meets North Ayrshire. It has a population of over 80,000 people. It is one of the smallest in terms of area (29th) and population (27th) of the 32 Scottish unitary authorities.

The main population centres of Greenock, Port Glasgow and Gourock are surrounded by smaller local communities such as Wemyss Bay, Inverkip and Kilmacolm and policing delivery is tailored to meet the needs of those communities. Partnership working in Inverclyde is well established and those partnerships deliver a highly effective police service which has a positive impact on local communities.

Inverclyde has a rich and renowned history in shipbuilding and the 'deep water docking' on the Clyde offers berth to visiting cruise ships. Much investment has

Been made in education within Inverclyde with the area being home to the Greenock campus of West College Scotland.

There are currently 198 licensed premises in Inverclyde, 73 are licensed for off sales only, 71 on sales only and 54 for both on and off sales.

OPERATION OF THE LICENSING (SCOTLAND) ACT 2005

Alcohol misuse, exacerbated by its accessibility, availability and affordability, is commonly acknowledged as a contributory factor in incidents of violence, disorder and antisocial behaviour.

Police Scotland continues to work with its partner agencies, including the licensed trade, to reduce the impact alcohol misuse has on local communities. By working together we can target those who fail or simply refuse to promote responsible trading practices. Together we can improve the safety and wellbeing of people, places and communities in Scotland.

Police Scotland currently have 3 levels for categorising licensed premises that come to our attention:

- Monitored Premises that require extra support and supervision. This can
 include premises coming to police attention through incidents or newly opened
 premises with inexperienced staff. A low key approach is used to address
 issues before they escalate.
- Intervention A formal intervention agreement is put in place to improve the safe and legitimate operation of a premises. This intervention plan, which contains a list of conditions, is agreed between all parties. The intervention period would last a minimum of three months and be subject to review.
- Problematic Premises deemed problematic will normally be the subject of a premises licence review submission by Police Scotland to the Licensing Board.

Any categorised premises will be subject to regular inspections to ensure compliance and will form part of the tasking regime for the night time economy action plans. All inspections, pro-active, re-active or planned are submitted via the Innkeeper system.

Board Decisions

Figures for the period 1st April 2022 to 31st March 2023 show that there were a total of 5 premises within Inverclyde which were monitored and subject to regular inspections. There was 1 premises subject of a premises review.

Section 84 – Personal Licence Reviews – No individuals were subject of a personal licence review.

Section 94 – Exclusion Orders – There were 6 exclusion orders.

Section 97 – Closure Orders – There have been 1 closure orders issued.

Section 104 – Buy/attempt to buy alcohol on behalf of a child - No individuals were charged for committing this offence during the period.

Section 108 – Deliver alcohol to person under the age of 18 – No persons were charged for committing this offence during the period.

Section 111-116 – Drunkenness/Disorder Offences - No persons were charged under these sections during this period.

PREVENTING THE SALE OR SUPPLY OF ALCOHOL TO CHILDREN OR YOUNG PEOPLE

Partnerships

Partnership working is key to delivering tangible outcomes and we continue to strengthen our relationships with all agencies, community representatives and local residents to ensure our services are co-ordinated, effective and efficient and address the needs of our communities.

IT'LL COST YOU - Proxy Purchase Campaign

This Campaign focused on hot spot areas with Educational interventions supported by third sector partners.

The main aims of the campaign were to

- Reduce the number of attempted purchases of alcohol for under 18s.
- Reduce crime and antisocial behaviour in the area.
- Reduce the vulnerability of those abusing alcohol under 18.
- Reduce the number of hospital admissions for under 18s with alcohol related injuries.
- Educate the public regarding the offence and dangers of proxy purchase within our communities.
- Educate Off-Sales and Licensed Premises to highlight the dangers of Proxy Purchase and operate within the Licensing Objectives.

The success of initiatives such as "Challenge 25" and joint work with Inverclyde Council have reduced the direct sale of alcohol to those under 18, however alcohol related violence and anti-social behaviour illustrate that younger age groups are increasingly gaining access to alcohol by other proxy sales. The most common method involves asking adults to buy alcohol for them.

The Licensing (Scotland) Act 2005 makes it an offence for a person to act as an agent for a child in purchasing or attempting to purchase alcohol'. This is known as proxy purchase. The penalties for this offence include a fine of up to £5000 and/or three months in prison.

With the assistance from the community police information was distributed to off licenses alongside bottle marking initiatives and engagement with the License holders.

Major supermarkets were approached and joint social media posts were published with the major supermarket retailers. These premises also allowed campaign material to be left at alcohol aisles and front doors to their premises publicise the campaign.

Morton football club, Inverclyde Council were supportive of the campaign.

The campaign continued with joint initiatives with the safer communities departments carrying out engagement events at shopping centres within Inverclyde, local community Gala days and West of Scotland College campus through student services.

There has been a slight decrease across the division on youth related alcohol incidents but has also highlighted the importance for the continuation of the campaign where certain areas have been highlighted for attention.

"I am Me"

Renfrewshire and Inverclyde Division works in partnership with "I Am Me" providing a network of local businesses to create 'Keep Safe' places for disabled, vulnerable, and elderly people. There are currently 156 Keep Safe places in the Division, 19 of them are licensed premises. The Keep Safe Ambassador Programme has continued in the Division and now has 114 High School Ambassadors which has more than doubled from the previous year, 12 Police Scotland Youth Volunteer Ambassadors, 40 Ambassadors with a learning disability and 9 Keep Safe Ambassador trainers across the Division. This provides vulnerable sections of the community areas where they can safely report crime. Such areas have been set up in the central business district where there is a higher proportion of on/off sales premises.

Inverclyde Partnership Hub

In 2021 Inverclyde Partnership Hub was formed and implemented by Police Scotland to operate within Greenock Police Office. It was developed utilising good working practices adopted from elsewhere and tailored to operate in Inverclyde, building on strong partnership foundations already established. The aim of the Inverclyde Community Partnership Hub is to work with partners on a daily basis to tackle antisocial behaviour, violence, drug related deaths and identify vulnerability in Inverclyde by co-ordinating all partners in an efficient structured and cohesive manner.

The structure used ensures that the daily tasking and risk incidents are focused, relevant and with clearly identified areas of ownership.

Each meeting involves a review of Police, Fire, Community Warden or other significant incidents or events over the previous 24-hour period. Information is pro-actively disclosed to partners who attend the daily meetings where reasonable, appropriate, proportionate and lawful to do so for effective and early intervention. Key to the development of the Inverclyde Partnership Hub has been full engagement and inclusion of key partners who have a responsibility for protection and wellbeing of our communities.

TACKLING SERIOUS AND ORGANISED CRIME

The Serious Organised Crime Taskforce was set up to ensure Scotland can respond robustly to the threat posed by organised crime, identify improvements, and ensure all agencies are working to the same aims to raise public awareness. Membership of the group includes the Solicitor General; the Police Service of Scotland; the Prison Service; Her Majesty's Revenue and Customs (HMRC); National Crime Agency (NCA); Society of Local Authority Chief Executives (SOLACE); Her Majesty's Inspectorate of Constabulary Scotland (HMICS) and Scottish Business Resilience Centre (SBRC).

Its remit is to work together to help deliver the Scottish Government's commitment to tackling serious organised crime by:

- Identifying priorities for tackling serious organised crime (SOC) in Scotland.
- Sharing best practice and improving co-ordination between law enforcement agencies and others;
- Identifying innovative ways of working together and encouraging better ways of working together;
- Developing a coherent Scottish response on reserved and other SOC issues; and
- Making proposals for legislation, research and other measures to tackle SOC.

There are several groups operating within the Renfrewshire and Inverclyde area, some of which have connections to the licensed trade, via licensed premises, second hand dealers, tanning salons and car wash facilities. Police Scotland, in conjunction with our partner agencies, have identified innovative ways to disrupt such organisations who are targeted through multi-agency days of action. Whilst it can be difficult to link these groups to serious crimes, targeting other crimes has proven to be a useful tool in disrupting their operations.

PROPOSED ACTIVITY FOR THE YEAR AHEAD

Enforcement Operations

The Licensing department will continue to plan and co-ordinate multi agency operations with officers from Home Office Immigration Enforcement (HOIE), Her Majesty's Revenue and Customs (HMRC) and Inverclyde Council targeting all forms of licensed premises and persons within the area.

To conclude we would like to thank you for your continued support during what has been a challenging year for all. We have all had to adapt to a new way of working and ever changing circumstances which has been embraced by all.
