#### 1.0 PURPOSE

- 1.1 This report requests the Council to appoint the Leader and Depute Leader of the Council, the Leader of the Minority Groups and to appoint Members to Committees together with Conveners and Vice-Conveners.
- 1.2 The Council is also requested to appoint Member Champions.

#### 2.0 APPOINTMENTS TO COMMITTEES

- 2.1 Paragraph 54 of the Scheme of Administration requires the Council to ensure, as far as practicable, that in making appointments to Committees, Sub-Committees and Outside Bodies (but only where more than two representatives of the Council to an Outside Body are required) the balance of political representation on the Council is reflected.
- 2.2 Following the local government elections on 4 May, the political balance of the Council is as follows:-

Labour	8 Members
SNP	7 Members
Scottish Conservative and Unionist	2 Members
Scottish Liberal Democrats	1 Member
Independent	1 Member

Appendix 1 sets out the political representation on the Council and the practical effect of the numerical entitlement will be updated as a result of any political discussions.

#### 3.0 **RECOMMENDATIONS**

3.1 That the Council appoints the Leader and Depute Leader of the Council and the Leader of the Minority Groups; and

3.2 That the Council appoints Members to Committees, Sub-Committees and Boards together with Conveners and Vice-Conveners and also appoints the various Member Champions as set out in the schedule attached as Appendix 2.


