## 1.0 PURPOSE

1.1 This report seeks the Council's agreement to a proposed schedule of Committee meetings for the remainder of the 2016/17 cycle ending with a meeting of the Council on 29 June 2017.

## 2.0 BACKGROUND

- 2.1 This cycle was agreed by the previous Council in June 2016 as part of the 2016/17 timetable. It has, however, been necessary to alter 2 meeting dates as a result of the statutory meeting taking place on 25 May.
- 2.3 The Inverclyde Integration Joint Board, although included in the timetable, is a separate body and the dates are set by the Board and not the Council.
- 2.4 The proposed timetable for 2017/18 meetings will be submitted, as is usual in an election year, to the June meeting of the Council.
