# Subject: Request for names for the three A8 roundabouts in Port Glasgow

#### 1.0 PURPOSE

1.1 The purpose of this report is to seek approval of names for three roundabouts on the A8 in Port Glasgow.

# 2.0 SUMMARY

- 2.1 Transport Scotland and Transerve have requested that the Council give names to three roundabouts on the A8 in Port Glasgow in order to assist with traffic management.
- 2.2 Ward councillors and Port Glasgow Community Council were consulted in respect of this matter, and their responses have been reflected in the proposed names.

# 3.0 RECOMMENDATIONS

- 3.1 It is recommended that the roundabouts on the A8 trunk road in Port Glasgow should be named:
  - 1 Glen Roundabout
  - 2 Kingston Roundabout
  - 3 Comet Roundabout

# 4.0 BACKGROUND

4.1 Transport Scotland and Scotland Transerve requested that the Council give names to three roundabouts on the A8 Trunk Road in Port Glasgow. Generally, trunk road roundabouts are named and this is found useful as a reference when dealing with traffic management issues. Transport Scotland will fund and erect the poles/nameplates if suitable names can be agreed by the Council.

### 5.0 PROPOSAL

- 5.1 The three roundabouts are located to the west, to the northwest and to the east of Gallagher Shopping Park and are numbered 1, 2 & 3 on the Location Plan (Appendix 1).
- 5.2 For the purposes of consultation, suggestions for the roundabout names were made by Regeneration & Planning to the ward councillors and Port Glasgow West Community Council. The suggestions and alternatives suggested in response to the consultation exercise were as follows:

Roundabout 1 Glen Roundabout Devol Roundabout

<u>Roundabout 2</u> Kingston Roundabout Birkmyre Roundabout

Roundabout 3 Port Glasgow Town Roundabout John Wood Roundabout Russell Roundabout Comet Roundabout Glenhuntly Roundabout

  - 1 Glen Roundabout
  - 2 Kingston Roundabout
  - 3 Comet Roundabout
