Glasgow City Deal - Outline Business Case Update

## 1.0 PURPOSE

1.1 The purpose of this report is to provide Members with an update on the submission of the Outline Business Cases for Inverkip and Greenock Ocean Terminal.

#### 2.0 SUMMARY

- 2.1 In 2013 the Clyde Valley Councils which together cover the 'City Region' of Glasgow collectively pursued a bid to the UK Government to establish a City Deal Agreement, similar to those established in England, with a view to bringing forward a major investment programme to stimulate economic growth for the benefit of residents and businesses in the Glasgow City Region.
- 2.2 As part of the approval process required for infrastructure projects, the Committee agreed at its meeting on 5 October for the submission of the Outline Business Cases for Inverkip and Greenock Ocean Terminal to take place.
- 2.3 The business cases were duly presented to the Glasgow City Region Cabinet on 11 October 2017 and approval was granted to develop the Final Business Cases for both projects.

### 3.0 RECOMMENDATIONS

3.1 That the Committee note that the Outline Business Cases for Inverkip and Greenock Ocean Terminal were submitted to the City Region Cabinet and were granted approval to proceed to Final Business Case preparation.

#### 4.0 BACKGROUND

- 4.1 In 2013 the Clyde Valley Councils which together cover the 'City Region' of Glasgow collectively pursued a bid to the UK Government to establish a City Deal Agreement, similar to those established in England, with a view to bringing forward a major investment programme to stimulate economic growth for the benefit of residents and businesses in the Glasgow City Region.
- 4.2 Twenty Infrastructure Projects received approval by the City Region Cabinet to progress through an iterative approval process. Inverclyde has three projects, Inverkip, Greenock Ocean Terminal and Inchgreen.
- 4.3 Projects progress through a three stage approval process strategic, outline and final and at each stage a number of milestones require to be achieved. Projects cannot proceed to construction contract award until Final Business Case approval has been granted both by the sponsoring Local Authority and City Deal.
- 4.4 Following approval by the City Region Cabinet, the projects for Inverkip and Greenock Ocean Terminal will progress as identified in the recommendations made in the report approved by Committee on 5 October 2017.
