1.0 PURPOSE

1.1 To advise the Committee of the 2017/18 projected out-turn for the Policy & Resources Committee as at period 6, 30 September 2017.

2.0 SUMMARY

- 2.1 The total revised Committee budget for 2017/18 is £16,724,000. This excludes Earmarked Reserves of £2,365,000.
- 2.2 The latest projection, excluding Earmarked Reserves, is an underspend of £623,000. This is an increase of £441,000 in the underspend since Period 4.
- 2.3 The main reasons for this underspend are:
 - a) £500,000 release of non-pay inflation contingency.
 - b) £53,000 overspend on overall employee budget
 - c) £50,000 over recovery of prior years' council tax.
 - d) £45,000 over-recovery on DWP grants.
 - e) £40,000 underspend on Pension Fund costs
- 2.4 The Earmarked Reserves for 2017/18 totals £2,365,000 of which £881,000 is projected to be spent in the current financial year. To date expenditure of £433,000 (49.15%) has been incurred which is £54,000 more than the phased budgeted spend to date. It is to be noted that Earmarked Reserves reported in appendix 4 excludes Earmarked Reserves for Asset Plans and Strategic Funds.
- 2.5 The Common Good Fund is projecting a surplus fund balance at 31 March 2018 of £15,210. This is below the recommended minimum level of reserves of £100,000. As part of the 2017/18 Budget action was taken to increase the annual surplus and as a result the Fund Balance will increase over the coming years. An action to continue to monitor the replenishment of balances was agreed with Audit Scotland as part of the 2016/17 Annual Report to Members.

- 3.1 That the Committee note the 2017/18 projected underspend of £623,000 for the Policy and Resources Committee as at Period 6, 30 September 2017.
- 3.2 That the Committee note the projected fund balance of £15,210 for the Common Good Fund and that action was agreed as part of the 2017/18 budget to begin to increase the fund balance to its recommended level.
- 3.3 That the Committee approve the virement totalling £14,340 as detailed in Paragraph 6.1 and Appendix 6.

4.0 BACKGROUND

4.1 The purpose of this report is to advise the Committee of the current position of the 2017/18 budget and to highlight the main issues contributing to the projected underspend of £623,000 in 2017/18.

5.0 2017/18 CURRENT POSITION

- 5.1 The current projection is an underspend of £623,000. The following are the material variances:
- 5.2 The following material variances relate to the Environment, Regeneration & Resources Directorate:

Finance - £210,000 underspend

<u>Employee Costs</u>: £66,000 projected underspend mainly due to additional turnover savings from vacancies within Revenues & Customer Services. This is a reduction in the underspend reported to the last Committee of £8,000.

Income: An over-recovery of £151,000 is being projected. This is mainly due to an overrecovery of income in relation to DWP Benefit's grants of £45,000 and an over recovery of prior years' Council Tax Income of £50,000 as previously reported.

Legal & Property - £67,000 overspend

<u>Employee Costs</u>: An overspend of £45,000 is being projected mainly due to turnover target not being met. This is a reduction in overspend of £14,000 since last reported at Committee.

<u>Income:</u> An under-recovery of £40,000 mainly due to a £30,000 under-recovery for liquor licences due to fewer applications received, this is an increase of under-recovery of £17,000 since period 4.

5.3 The following material variances relate to the Education, Communities & Organisational Development Directorate:

Organisational Development, H.R. & Communications - £67,000 overspend

<u>Employee Costs:</u> £65,000 projected overspend mainly due to £23,000 additional turnover savings from vacant posts and reduction in hours off-set in full by a £71,000 overspend in relation to Manager post currently being funded from the overall Education Directorate underspend. This represents an increase in overspend of £5,000 since last reported at Committee.

5.4 The following material variances relate to the Miscellaneous budget.

Miscellaneous – £545,000 underspend

<u>Inflation Contingency</u>: There is a projected underspend of £500,000 based on current estimated calls on inflation contingency. This is an increase on underspend of £350,000 since last reported to Committee and represents the release of the majority of the unallocated balance as most areas of expected inflation have been clarified for 2017/18.

Pension Fund: This is a projected underspend of £40,000 based on current monthly costs.

6.0 VIREMENT

6.1 The Committee is asked to approve virements totalling £14,340 as detailed in Appendix 6. The Legal Services employee budget will be increased by £14,340 to part fund a new solicitor with this coming from Property Services Training and Travel budgets. The virement has been reflected within the report.

7.0 EARMARKED RESERVES

7.1 Appendix 4 gives a detailed breakdown of the current earmarked reserves position. Total funding is £2,365,000 of which £881,000 is projected to be spent in 2017/18 and the remaining balance of £1,484,000 to be carried forward to 2018/19 and beyond. It can be seen that expenditure of £433,000 has been achieved which is £54,000 more that the phased budgeted spend to date and represents 49.15% of the annual projected spend.

8.0 COMMON GOOD FUND

8.1 The Common Good Fund is projecting a surplus fund balance at 31 March 2018 of £15,210. This is below the recommended minimum level of reserves of £100,000. As part of the 2017/18 Budget action was taken to increase the annual surplus and as a result the Fund Balance will increase over the coming years. An action to continue to monitor the replenishment of balances was agreed with Audit Scotland as part of the 2016/17 Annual Report to Members.
