Subject: Access to Free Sanitary Products

#### 1.0 PURPOSE

1.1 The purpose of this report is to update and inform the committee on the implementation of the Scottish Government commitment to provide free access to sanitary products in schools and community facilities.

#### 2.0 SUMMARY

- 2.1 On 30 May 2018, the Scottish Government committed funding to provide "access to free sanitary products to students in schools, colleges and universities". To support equality, dignity and rights for those who menstruate and to ensure that lack of access to products does not affect an individual's ability to participate in education at all levels.
- 2.2 This commitment continues to roll out a Scotland wide initiative with the basis on the main findings of the pilot study from Aberdeen in 2018. A set of Guiding Principles is available to help shape local delivery models.
- 2.3 Using the national framework for sanitary products, a variety of product types are now sourced and available for use in Inverclyde Schools, Libraries, Youth Zones and Community Centres.
- 2.4 Inverclyde Council received a total of £25,733 to set up and provide products from August 2018 to March 2019. The Scottish Government has issued a Monitoring Framework to monitor spend from September 2018 to February 2019. The funding allocation for 2019/20 is £72,947.

#### 3.0 RECOMMENDATIONS

3.1 That Inverciyde Council continues to support the commitment to roll out Access to Free Sanitary Products across schools and increases this in 2019/20 to include a range of places where sanitary products are available for those who need them. Non-school locations should have a range of products available at all times.

#### 4.0 BACKGROUND

- 4.1 On 30 May 2018, the Scottish Government announced funding to local authorities to provide access to free sanitary products to students in schools, colleges and universities and to provide access to products during school holidays and weekends.
- 4.2 The Scottish Government also issued a set of guiding principles which the local delivery model should be based on:
  - Protecting student's dignity, avoiding anxiety, embarrassment and stigma.
  - Making a range of products in places that people use.
  - A response that is reflective of communities views and needs.
  - An efficient and effective approach which demonstrates value for money.
  - Individuals being able to get sufficient products to meet their needs.
  - Gender Equality ensuring anyone who menstruates can access products including transgender men and non-binary individuals and that language is gender inclusive.
  - Awareness raising and education to both promote the 'offer' and change cultural norms.
- 4.3 The findings of the Aberdeen pilot project in 2018 confirmed access to sanitary products as an issue for some people and different groups are affected in different ways. The key learning point from the pilot was that in educational institutions, there was embarrassment about periods generally and having to ask a staff member for products is a particular issue for young pupils. School staff noted a need for education around menstruation and sanitary products to reduce stigma and normalise discussion of menstruation. Provision during school holidays and weekends should also be easily accessible and discreet for people on low income.
- 4.4 Prior to October 2018, schools in Inverclyde held supplies of sanitary products for pupils who asked for them, this was the case in both primary and secondary schools. There was no charge for these products and they tended to be required in one-off emergencies. However, there is a stigma attached to menstruation and some pupils may not have felt comfortable about asking school staff for sanitary products.

#### 5.0 CURRENT POSITION

#### 5.1 Product Sourcing within Invercivde

This is a national framework, which offers schools a selection of sanitary products across 4 suppliers. An order was placed with Hey Girls and deliveries made to schools in October 2018. Appendix 1 details the types of sanitary products and quantities purchased between September 2018 and February 2019.

#### 5.2 Proposed Delivery Model within Inverclyde

All Head Teachers have received the Scottish Government Guiding Principles and Good Practice information for the provision of sanitary products in schools, to share amongst staff.

Sanitary products are now available in both primary and secondary schools and are located in medical rooms, staff rooms, reception areas, pupil support areas and various toilet areas. Plastic storage boxes are located in each of these areas and are stocked with a variety of sanitary products ensuring accessibility without having to ask a member of staff. Tote bags will be purchased for secondary school toilet cubicles and stocked with multiple types of products that can be accessed in privacy.

Inverciyde has established a short life working group to support the development, delivery and measurement of impact of accessing free sanitary products as part of the tackling poverty and gender inequality agenda. The short life working group has relevant representatives from procurement, children and young people's rights, school nursing, teachers, youth workers, and facilities services.

#### 5.3 Delivery Model - Secondary Schools

Secondary schools have been given a range of sanitary products to choose from, placed in a

variety of discrete and easily accessible locations including gender neutral toilets. The locations within the secondary schools have been identified through engagement and consultation with Pupil Voice representatives coming together to the Inverclyde Pupil Network, to share what is good in their school and how other pupil voice representatives can adapt this practice.

Representatives from the Inverclyde Pupil Network attended a training workshop facilitated by Hey Girls and the Children's Rights Officer in December 2018. Pupils were given an action sheet to complete and return at the end of February 2019. The views and needs detailed in the responses will be collated and will inform future planning.

It was anticipated that there may be an increase in the number of sanitary bin uplifts and possible increase in the number of sanitary bins around school toilets. There have been no reported increases between October 2018 and February 2019.

#### 5.4 <u>Delivery Model – Primary Schools</u>

Primary schools are more likely to know which pupils may require the products, because the numbers are likely to be low and they have been given a smaller range of sanitary products to be made freely available for pupils to access when they need them. Pupils in Primary 6 and 7 will learn about the changes in their body as part of the Curriculum of Excellence and the offer of free sanitary products and how to access them will be raised at this time. Parents will receive letters and notification from schools on how they can access the free sanitary products on behalf of their child. The short life working group will have responsibility to gather information from all the primary schools to share with the Scottish Government as part of the national framework agreement.

#### 5.5 Delivery Model in the Community for evenings, weekends and holiday periods

In addition to school sites, sanitary products are now available in Libraries, Youth Zones and Community Centres throughout Inverciyee to cover weekends and school holidays.

#### **FUTURE PROPOSAL 2019/20**

#### 5.6 Funding Allocation for 2019/20

On 30 November 2018, COSLA Leaders agreed to the proposed funding to expand access to free sanitary products and "aim to increase the number and range of places where sanitary products are available for those who need them. We will do this through working with a range of public and private sector organisations and with additional third sector partners to expand the geographical spread of support". The budget allocated for 2019/20 is £72,947.

#### 5.7 Product Sourcing within Inverclyde 2019/20

A mini competition is required using the National Procurement Framework of suppliers, through the Scotland Excel Framework as the allocated budget for 2019/20 exceeds £25,000.

#### 5.8 Reusable Products

The Scottish Government support the principle of reusable products on both value for money and environmental grounds. Two types of reusable products are within each secondary school however a local delivery plan needs to be developed to consider how to make products available and educate those pupils who wish to use them.
