Subject: Towns and Villages Environmental Improvements Update

#### 1.0 PURPOSE

1.1 The purpose of this report is provide the Committee with an update on the progress in respect of the two Town and Village Centres funding streams funded from earmarked reserves.

#### 2.0 SUMMARY

- 2.1 The Council approved an allocation of £500,000 for the Towns and Villages Environmental Improvements. This paper presents the Final Account for the Towns and Villages Improvements contract and gives an update on the Community Spend drawdowns by the Regeneration Forums and Community Councils.
- 2.2 In March 2017 a further £2.5million was agreed for Town and Village Centres. Of the £2,500,000, it was agreed at this Committee that an allocation of £1,900,000 be allocated to Greenock, with £250,000 allocated to both Port Glasgow and Gourock and the balance of £100,000 shared equally amongst the 4 villages.
- 2.3 The original £500,000 project is now completed and the use is detailed in Appendix 1 of the report. It is proposed to add the remaining balance of £162,503 to the main Town and Village Centres project as shown in Appendix 2.
- 2.4 Two specific expenditure requests are made as part of this report, these are, painting contract for the Gourock promenade railings and the Town Centre Landscaping Maintenance contract in Port Glasgow as detailed in the body of the report.

## 3.0 RECOMMENDATIONS

- 3.1 It is recommended that the Committee:
  - a) notes the completion of the Towns and Villages environmental improvement projects, the monies spent to date and the balance remaining and,
  - b) agrees that the projects detailed in paragraphs 6.4 and 6.5 are approved as Town Centre priority projects.

#### 4.0 BACKGROUND

- 4.1 The original Towns & Villages £500,000 allocation was ringfenced for a number of improvement projects within Inverclyde in April 2016. The Consultants, Ironside Farrar, provided Inverclyde Council with a suggested number of projects and an indicative spend breakdown for each Town and Village.
- 4.2 The table below sets out the estimated breakdown of the £500,000 across each of the locations.

- 4.3 The Environment & Regeneration Committee approved the recommendation of the Corporate Director, that Riverside Inverclyde should be engaged as delivery agent for the project and to appoint landscape architects from ri's Consultancy Framework, which will be charged against individual projects.
- 4.4 The £75,000 Shop Front Improvements were administered by the Council's Economic Development Team with the £425,000 balance for ri to manage. The Community Councils and Regeneration Forums were to agree which projects are to be funded from the £90,000 Community Spend and applications to the fund are authorised by ri. The balance of £335,000 (£271,000+£64,000) was for capital improvement projects commissioned by ri, with agreement with the Community Councils and Regeneration Forums.

### 5.0 CURRENT POSITION

5.1 Of the total grant award of £425,00, £262,497 has been spent to date with the balance of £162,503 remaining.

5.2 Appendix 1 provides detail on a Town Centre/Village Centre level. It is proposed that the remaining sum of £162,503, can now be added to the £2,500,000 award for the 2<sup>nd</sup> phase of the Towns and Villages Improvements.

# 6.0 £2,500,000 GRANT AWARD PROGRESS

- 6.1 Of the £2,500,000 agreed by the Environment & Regeneration Committee in March 2017, £1,900,000 was allocated to Greenock, with £250,000 allocated to both Port Glasgow and Gourock. The remaining £100,000 is split equally between the 4 villages for the Community Councils to agree expenditure.
- 6.2 The Greenock, Port Glasgow and Gourock Forums meet every quarter to discuss proposed projects and agree expenditure breakdowns in order to recommend projects to the Environment & Regeneration Committee for priority approval.
- 6.3 Appendix 2 provides the latest position on the basis that the £162,503 remaining from Phase 1 is transferred to this phase. There are 2 requests for expenditure detailed below for the Environment & Regeneration Committee to consider.

### 6.4 PROJECT PROPOSALS – GOUROCK REGENERATION FORUM

## Promenade Railings

Inverclyde Council have recently undertaken a painting contract to the promenade railings, however a number of areas had been excluded and the Community Council suggested to the Forum that the Towns and Villages Fund be used to extend the painting contract to include the omitted areas from McInroy's Point up to Cove Road.

The total costs for extending these works to repair and paint all 5 areas, amounts to c£65,000. (£49,388 for painting, £11,500 for fencing repairs & £4,112 for landscaping).

The Forum recommends that c£17,000 (£13,288 for painting plus ancillary repairs etc) of the Towns and Villages remaining budget is confirmed to support the extension of the painting contract for Section 5 only, ie Cove Road, within the 2019/20 financial year.

### 6.5 PROJECT PROPOSALS - PORT GLASGOW REGENERATION FORUM

# Port Glasgow Town Centre Planting

The current 3 year contract for the Town Centre landscaping came to an end and the contract has been retendered. The preferred contractor has been identified and funding in the amount of £23,856 is requested to support their appointment for the next three years. This project to be funded from a combination of remaining funds in the Phase 1 and Phase 2 works plus an expected underspend in the Princes Street Footway contract.

The Forum recommends that the preferred contractor is appointed immediately on a 1 year basis with a view to extending to a 3 year appointment once the Final Account for the Princes Street Footpath and Carriageway improvements is agreed and the underspend confirmed.

### 7.0 FINANCIAL IMPLICATIONS

7.1 The £2.5m project breakdown of costs spent against every town and village can be seen at Appendix 2.

It should be noted that there are some recurring revenue commitments being funded from a small number of projects which have been proposed/progressed. Decisions will be required in future as to whether to continue funding these projects from within the Committee budgets.

## 8.0 CONSULTATIONS

8.1 The Chief Financial Officer, Head of Legal and Property Services and Head of Regeneration & Planning have been consulted on the contents of this report.
