## 1.0 PURPOSE

1.1 Further to the statutory consultation process undertaken in terms of the Road Traffic Regulation Act 1984 and the Local Authorities’ Traffic Orders (Procedure) (Scotland) Regulations 1999 on The Inverclyde Council (Various Roads) (Outer Greenock) (Waiting Restrictions) (Variation No. 11) Order 2020 (the Proposed TRO), the purpose of this report is to:-

- Request that the Committee adopt the Rules of Procedure for the purposes of the special meeting;
- Advise the Committee in relation to the Proposed TRO of the discussion between Council Officers and the person who has, as part of the public consultation, objected to the Proposed TRO (the Objector); and
- Facilitate the effective fair and proper hearing by the Committee of the Objector who has not withdrawn their objections in order that the Committee can consider their objection (the Objection) and come to a formal recommendation on the Proposed TRO.

## 2.0 SUMMARY

2.1 Local Authorities are empowered to make Orders under the Road Traffic Regulation Act 1984 as amended and under the Council’s Scheme of Delegation the Head of Roads & Environmental Services is responsible for the making, implementation and review of Traffic Management Orders and Traffic Regulation Orders.

2.2 The proposed TRO was issued for public consultation on 08 September 2020 with responses invited by 01 October 2020. The documents published as part of this consultation contained errors in the description of the restrictions. These errors were corrected and a second public consultation was carried out for this proposed TRO with amended documents. The proposed TRO was issued for a second public consultation on 09 October 2020 with responses invited by 30 October 2020. During the period of both public consultations, 1 objection was received. Officers wrote to the objector and the objector did not respond therefore their objection is considered to be maintained.

- 2.3 It is necessary that the Objector be given an opportunity to be heard before the Committee before it reaches a decision on whether or not to recommend the Proposed TRO for formal approval of The Inverclyde Council. The special meeting has been convened to provide such an opportunity.
- 2.4 Because of the requirements of the statutory process and the formal nature of the special meeting, it is vital that the Objector has a fair and impartial hearing and the Rules of Procedure provide for this.

### **3.0 RECOMMENDATIONS**

It is recommended that the Committee:

- 3.1 Approve the Rules of Procedure as detailed in Appendix 1.
- 3.2 Consider the terms of Appendix 2 in relation to the Objections.
- 3.3 Allow the Objector an opportunity to be heard at the special meeting in accordance with the Rules of Procedure.
- 3.4 Consider the Objection and such oral representations on it made by the Objector and officers at the special meeting and thereafter **either**:
- 3.4.1 Dismiss the Objection, approve the Proposed TRO as detailed in Appendix 3 and refer it to the next meeting of The Inverclyde Council recommending that The Inverclyde Council formally approve the Proposed TRO and remit it to the Head of Roads & Environmental Services and the Head of Legal and Property Services to arrange for its implementation in accordance with the statutory procedure;
- or**
- 3.4.2 Uphold in whole or in part the Objection and remit it to the Head of Roads & Environmental Services and the Head of Legal and Property Services to amend the terms of the Proposed TRO to deal with the part or parts of the Objection so upheld in accordance with the decision of the Committee and to report to a future meeting of the Committee with the Proposed TRO as further amended for approval.

## **4.0 BACKGROUND**

- 4.1 Local Authorities are empowered to make Orders under the Road Traffic Regulation Act 1984 as amended and under the Council's Scheme of Delegation the Head of Roads & Environmental Services is responsible for the making, implementation and review of Traffic Management Orders and Traffic Regulation Orders.
- 4.2 Officers proceeded with a public consultation process in accordance with the legislation. At its meeting of 14 January 2021 this Committee was updated as to the consultation process and it authorised officers to make arrangements for the holding of a public hearing in the form of this special meeting.
- 4.3 Officers have continued to engage with the Objector since that date to advise them of the arrangements for and proposed procedure at this special meeting. Officers have provided the Objector with a statement of case which sets out the position of the Head of Roads & Environmental Services as regards the Proposed TRO; the statement of case is in Appendix 4.
- 4.4 Appendix 2 provides the full text of the Objection and the correspondence with officers.
- 4.5 Before making a proposed TRO, the Council is, in terms of the Act and the Regulations, required to take into consideration any Objections timeously received by them and to give any Objectors an opportunity to be heard by them. This special meeting is therefore necessary to permit the Objector to be heard by the Committee in terms of the recommendations above.
- 4.6 As the hearing of Objections is a statutory entitlement for Objectors, the Committee will be discharging legal responsibilities at the special meeting effectively as if it were a formal tribunal or board with the obligations which are already familiar to Elected Members as regards hearing and continuity of attendance.

## **5.0 PROPOSALS**

- 5.1 The form of the Proposed TRO which officers are recommending for approval is included at Appendix 3 of this report.
- 5.2 The special meeting will proceed effectively as if a formal tribunal or board. In the interests of fairness, openness and transparency it is therefore necessary that the basis on which the hearing element of the meeting will proceed be formalised. Officers have therefore prepared draft Rules of Procedure of this meeting per Appendix 1. This has been circulated to the Objector prior to this meeting and are recommended for approval by the Committee.
- 5.3 Because of the formality of the hearing process and the statutory process for making TROs, only certain decisions of the Committee in this matter are competent. Further it is vital that the Objectors have a fair and impartial hearing and the Rules of Procedure provide for this. The decisions which the Committee can competently make are: to dismiss the Objections; to uphold the Objections; or to uphold part of the Objections and dismiss other parts of the Objections. If the Objections are upheld in part, it will be necessary for officers to report back to the Committee at a future date with detailed wording. These eventualities are addressed in the possible Committee outcomes specified in paragraph 3.4.
- 5.4 The Committee is asked to note that, if approved, the Proposed TRO may not be implemented until the making of the Order has been advertised to allow any persons who so wish a period of six weeks to question the validity of the Order in terms of the Road Traffic Regulation Act 1984.

# APPENDIX 1

## **Appendix 1 – Rules of Procedure**

### **INVERCLYDE COUNCIL**

#### **ENVIRONMENT AND REGENERATION COMMITTEE**

##### **PROCEDURE AT PUBLIC HEARING INTO OBJECTIONS IN RELATION TO TRAFFIC REGULATION ORDER**

At the hearing, the order of the proceedings will be as follows:

- a) The Chair will conduct the hearing. Immediately after opening it, he will introduce the members of the Committee and the officer(s) present and identify and list those persons who wish to be heard during the hearing. It is therefore vital that any person who wishes to participate attends the opening.
- b) The Chair will outline the procedure, explaining that the hearing will take the form of a discussion which he will lead based on the agenda issued to those objectors who have indicated to the Council that they wish to attend and be heard at the hearing.
- c) The arrangements for the hearing have been designed to create the right atmosphere for discussion, to eliminate or reduce formalities and to give everybody a fair hearing.
- d) As each objection listed on the agenda is reached, the Chair will identify those persons who wish to engage in the discussion of the particular issue(s) raised by the objection. Several objectors with shared concerns may choose a spokesperson and this will be helpful to the process; in the event that a number of objectors decide to act together in this way, the Chair will allow a reasonable extension of the time limits set out below.
- e) The Council officer(s) will be invited to describe and present the case for the traffic regulation order in respect of which the objection has been made, to set the scene for the discussion, with a time limit of 5 minutes per objection.
- f) Each objector will be invited to speak to his objection and comment on the description/presentation by the Council officer(s), with a time limit of 5 minutes. Repetition of similar points is to be avoided and will be managed by the Chair.
- g) The Council officer(s) will be invited to reply to the speech of the objector (introducing no new material), restricted to a time limit of 5 minutes. The Chair will allow the objector the final word (introducing no new material), if he/she wishes it, restricted to a time limit of 5 minutes. The Chair will discourage repetitive or superfluous comments. He will indicate when he considers that sufficient clarification of a topic has been achieved, and the discussion will then move on to the next item on the agenda. At no time will cross examination be permitted.

h) The members of the Committee will then be invited by the Chair to ask questions of both the Council officer(s) and the objector. The role of the members of the Committee is only to hear, consider and make a decision on the evidence given by Council officer(s) and objectors.

i) The members of the Committee will then adjourn to consider their decision. The decision of the Committee will be intimated to the Council officer(s) and the objectors orally. Any votes will be held in public. It is anticipated that the decision of the members of the Committee will be intimated on the day of the public hearing but, if that is not possible for any reason, the public hearing will be re-convened. If the decision of the members of the Committee is to uphold an objection in whole or in part, the matter may be remitted to Council officer(s) to modify the traffic regulation order to deal with the objection in accordance with the decision of the members and report to a future meeting of the Environment and Regeneration Committee.

Objections to the Parking Restriction on MacKenzie Street, Greenock

I would be grateful if you would lodge my objection to the proposed parking restrictions in MacKenzie Street, Greenock.

In general terms the main cause of the traffic build up in this area is due to the Snack Van situated on this street. This van causes parking issue for existing business operating in this area. Cars are continuously around the snack van causing distraction to road users and present a hazard when heavy goods vehicle, delivery vehicles and vans are trying to their daily deliveries.

Many of the business that operate in this area require parking to be available for the operation their businesses. I feel that it is unfair to put no parking restriction on the whole street. I think further discussion should be carried out with individual business premisses. My business in particular faces issues on a daily basis with contraflow to the snack van. The operator put's cones and take up at least 5 to 6 parking spaces on a daily basis with the snack van and her vehicle. I feel this vehicle would be more suited in McDougall Street where there is less traffic flow and would be able to have additional flow from the local train station.

The Head of Service – Roads and Transportation has noted and considered your objections and would respond to your grounds for objection as follows:-

*I acknowledge receipt of your objection to "The Inverclyde Council (Various Roads) (Outer Greenock) (Waiting Restrictions) (Variation No. 11) Order 2020" ("the proposed TRO") in relation to the proposed restriction on MacKenzie Street, Greenock.*

*The parking restrictions within the proposed TRO have been considered following a request from the owner of Cappielow Industrial Estate to assist delivery vehicles servicing the Estate. The Roads service have considered this request, while trying to maintain parking for as many drivers as possible within the Estate. The restrictions were kept to a minimum to allow vehicles to turn into the Estate and then to turn into each row of businesses within the Estate.*

*The enclosed plan shows the proposed restrictions which are also shown at <https://www.inverclyde.gov.uk/law-and-licensing/traffic-regulation-orders/outer-greenock-waiting-restrictions-variation-no-11-order-2020>. Drivers will still be able to park on some lengths of MacKenzie Street.*

*The proposed TRO does not have any impact on the licensed location of the snack van and therefore the Roads service are unable to comment on it. Please contact Inverclyde Council's Licencing Section (Contact: Anne Sinclair; Tel: 01475 712034) in relation to any concerns relating to the licence of the snack van.*



### **How to contact us**

### **What information do we need?**

Unless specifically agreed with you, the Council will only collect personal data about you which does not include any special categories of personal information about you. The information will however include details such as:

### **Why we need this information?**

You are giving the Council your personal information to allow us to make fully informed decisions when carrying out the statutory process in line with 'The Local Authorities' Traffic Orders (Procedure) (Scotland) Regulations 1999'. The Council also use your information to verify your identity where required, contact you by post, email or telephone and to maintain our records.

### **Legal basis for using information**

Processing your personal information is necessary for the performance of a task carried out in the public interest by the Council.

We, The Inverclyde Council in exercise of the powers conferred on us by Sections 1(1), 2(1) to (3), 4(2), 32(1), 35(1), 45, 53, 101 and 102 of the Road Traffic Regulation Act 1984 (as amended) (“the Act”) and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consulting the Chief Constable of the Police Service of Scotland (Seirbheis Phoilis na h-Alba) in accordance with Part III of Schedule 9 to the Act hereby make the following Order:

**1.0 Commencement and citation**

1.1 This Order shall come into operation on the \*\* day of \*\*, Two Thousand and \*\* and may be cited as “The Inverclyde Council (Various Roads) (Outer Greenock) (Waiting Restrictions) (Variation No. 11) Order 2020”.

**2.0 Interpretation**

2.1 Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

2.2 Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, modified, re-enacted, replaced or supplemented by any subsequent enactment.

2.3 The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment provided that where a prohibition or restriction which is imposed, varied or revoked by this Order is in conflict with a prohibition or restriction imposed by a previous Order, then the provision of this Order shall prevail.

2.4 The On-Street Plans forming Schedule 1 to this Order and titled “The Inverclyde Council (Various Roads) (Outer Greenock) (Waiting Restrictions) (Variation No. 11) Order 2020 On-Street Plans” are hereby incorporated into “The Inverclyde Council (Various Roads) (Outer Greenock) (Waiting Restrictions) Order 2013” and recorded in “The Inverclyde Council (Various Roads) (Outer Greenock) (Waiting Restrictions) Order 2013 Plan Index”.

2.5 The Plan Index forms Schedule 2.

2.6 The Interpretation Act 1978 (as amended) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament

**STATEMENT OF CASE**

## **Background**

### **Statement of Reasons**

It is considered necessary to make the above TRO to avoid danger to persons and other traffic using the roads mentioned below, to facilitate the passage on those roads of any class of traffic and to prevent the use of the roads by vehicular traffic in a manner which is unsuitable having regard to the existing character of the roads by introducing the proposed Order which will have the following effects:-

- Introduce a “No waiting at any time” restriction on parts of Old Inverkip Road, Lewis Road, South Street, Finnart Street, Campbell Street, Robertson Street, Finnart Road, Roxburgh Avenue, Ann Street, Mearns Street, Trafalgar Street, Dempster Street, Wellington Street, Knowe Road, MacKenzie Street and Pottery Street, all in Greenock; and
- Introduce a “No waiting at any time, no loading at any time” restriction on parts of Auchmead Road, Norfolk Road, Gateside Avenue, Dunlop Street, Baker Street, Regent Street, Dellingburn Street, Drumfrochar Road, Merino Road, Papermill Road, Glen Kinglas Road, Ingleston Street and Orchard Street, all in Greenock.

### **Introduction**

The Inverclyde Council introduced Decriminalised Parking Enforcement throughout Inverclyde in 2014. Since that time numerous requests have been received to introduce waiting and loading restrictions at various locations in Greenock. This Traffic Regulation Order (TRO) promotes various restrictions to address some of these requests.

During the promotion of this TRO one maintained objection was received in relation to the proposed waiting restrictions on MacKenzie Street.

The restrictions on MacKenzie Street are proposed following a request from the owners of part of Cappielow Industrial Estate who had difficulty servicing their section of the Estate with HGVs. Parked vehicles too close to junctions hinder the movement of HGVs.

### **Benefits**

IC consider benefits will be achieved in road safety terms by preventing collisions associated with parked vehicles and the obstruction of the carriageway for HGVs. Parking will be retained where possible to allow customers and staff of all of the businesses in the entire Estate to park there.

### **Public Consultation**

The proposed TRO was issued for public consultation on 08 September 2020 with responses invited by 01 October 2020. The documents published as part of this consultation contained errors in the description of the restrictions. These errors were corrected and a second public consultation was carried out for this proposed TRO with amended documents. The proposed TRO was issued for a second public consultation on 09 October 2020 with responses invited by 30 October 2020. One objection was received.

### **Maintained Objection and IC's Response**

The maintained objection raised key themes. The key themes are listed below and details of IC's responses to each of them are provided verbatim.

**Objection:** In general terms the main cause of the traffic build up in this area is due to the Snack Van situated on this street. This van causes parking issue for existing business operating in this area. Cars are continuously around the snack van causing distraction to road users and present a hazard when heavy goods vehicle, delivery vehicles and vans are trying to their daily deliveries.

Many of the business that operate in this area require parking to be available for the operation their businesses. I feel that it is unfair to put no parking restriction on the whole street. I think further discussion should been carried out with individual business premises. My business in particular faces issues on a daily basis with contraflow to the snack van. The operator put's cones and take up at least 5 to 6 parking spaces on a daily basis with the snack van and her vehicle. I feel this vehicle would be more suited in McDougall Street where there is less traffic flow and would be able to have additional flow from the local train station.

**Response:** I acknowledge receipt of your objection to "The Inverclyde Council (Various Roads) (Outer Greenock) (Waiting Restrictions) (Variation No. 11) Order 2020" ("the proposed TRO") in relation to the proposed restriction on MacKenzie Street, Greenock.

The parking restrictions within the proposed TRO have been considered following a request from the owner of Cappielow Industrial Estate to assist delivery vehicles servicing the Estate. The Roads Service have considered this request, while trying to maintain parking for as many drivers as possible within the Estate. The restrictions were kept to a minimum to allow vehicles to turn into the Estate and then to turn into each row of businesses within the Estate.

The enclosed plan shows the proposed restrictions which are also shown at <https://www.inverclyde.gov.uk/law-and-licensing/traffic-regulation-orders/outer-greenock-waiting-restrictions-variation-no-11-order-2020>. Drivers will still be able to park on some lengths of MacKenzie Street.

The proposed TRO does not have any impact on the licensed location of the snack van and therefore the Roads Service are unable to comment on it. Please contact Inverclyde Council's Licencing Section (Contact: Anne Sinclair; Tel: 01475 712034) in relation to any concerns relating to the licence of the snack van.

## **Council Comments**

For the purposes of this Special Meeting, Roads officers would make the following additional comments:

1. The licensing of the food van is subject to separate legislation. There is no benefit to the licensee to coning off spaces through the day which could be used by their customers. Any complaints regarding the operation of the van would need to be addressed as part of their licence, however it is noted that the licensee has no control over the manner in which their customers park.
2. Observations have noted that MacDougall Street is also busy with parking during working hours with fewer businesses who would benefit from the services of the food van.

**Conclusion**

IC submits that the objection should not be upheld and the TRO made as proposed.
