## **1.0 INTRODUCTION**

- 1.1 The purpose of this report is to ask the Board to consider the application by Mr Mark Kitchen to hold a public procession on 2 July 2022. The application is made in respect of a parade due to be held by the applicant's organisation, the Port Glasgow District 19 Orange Order on 2 July 2022.

## **2.0 SUMMARY**

- 2.1 Three objections have been received to the application to hold a public procession on 2 July 2022 in Port Glasgow. In accordance with the procedure for the Management of Public Processions, approved by the General Purposes Board on 13 June 2007, where an objection or representation has been received, and has not been withdrawn, a meeting of the General Purposes Board requires to be held to determine the application.

## **3.0 RECOMMENDATION**

- 3.1 The Board are asked to determine the application in light of the objections received, and any representations made by the applicant and objectors and /or their representatives, and consider whether any conditions should be imposed.

## 4.0 BACKGROUND

- 4.1 An application by Mr Mark Kitchen seeking consent of the local authority to hold a public procession in Port Glasgow on 2 July 2022 was received by the Council on 20 April 2022. The application was made by Mr Kitchen on behalf of the Port Glasgow District Orange Order. Seventy people are expected to attend with one band in attendance.
- 4.2 The procession is due to start at 8.45 am and the proposed route, as per the application, is Boglestone Avenue (Orange Hall), Ardmore Road, Springhill Road, Highholm Avenue, Balfour Street, Shore Street, Princess Street, John Wood Street, Bay Street, and Fore Street. The return route as stated in the application and is due to start at 5.30pm is Marloch Avenue, Auchenbothie Road, Dubbs Road, Boglestone Avenue with dispersal at Port Glasgow Orange Hall.

## 5.0 CONSULTATIONS

- 5.1 In accordance with the procedure for the Management of Public Processions, approved by the General Purposes Board on 13 June 2007, consultation has involved consulting with the community by giving information on appropriate processions through the Council's website, libraries and emails to Ward Councillors and the relevant Community Council.
- 5.2 Consultations have been carried out as detailed above and also with Police Scotland, and the Council's Roads and Public Protection Service.
- 5.3 None of the ward Councillors have objected to the application.

## 6.0 OBJECTIONS

- 6.1 Police Scotland has no objection to the procession and has confirmed there will be a Police presence. Police Scotland has commented that this is an annual parade and there have been no reported issues in the past. The parade route has been examined and is considered to be in order all as detailed in the report of Police Scotland which forms **Appendix 1** to this report. Furthermore, Police Scotland has advised that the applicant has agreed to certain conditions as follows:

1. The provision of 9 stewards escorting the parade along the length of the route, all of whom will be distinguishable by high visibility clothing. This achieves the preferred stewarding ratio for Police Scotland.
2. To make participants aware of street furniture on the route, which may prove to be a hazard.
3. No music shall be played whilst passing any place of worship whilst services are in progress.
4. The applicant will be present and in charge of the parade.
5. The parade will not start without the presence of Police Scotland.
6. All Police Scotland instructions must be followed.

- 6.2 The Council's Roads Service has confirmed by email dated 1 May 2022 it has no objection to the proposed procession.

- 6.3 There have been three objections received in relation to the proposed procession:

1. Objector 1:

This objector has objected to the timing of the event, and the proposed route, commenting that the parade will pass St John the Baptist Church at 9.30 am, either prior to or after the service and pass St Francis of Assisi RC Church near the end of Mass at 5pm or as the congregation is leaving church.

This Objector has commented further:

No Parades/ processions should be allowed to pass any place of worship at least 30 minutes before or after any scheduled service.

The timing of these parades should be altered to protect the elderly members of the congregation, who attend both of the above churches, from any alarm or distress.

A copy of emails received from Objector 1 are set out in **Appendix 2** to this report.

## 2. Objector 2

This Objector has commented as follows:

The proposed route to Port Glasgow Town centre to disperse at Fore Street will cause inconvenience to early Saturday morning shoppers and residents in the town centre.

Main objection, is the return of the parade which is due to start at 5.30pm, and will mean passing St Francis RC Church just as Mass would be due to end.

Such marches should not be permitted to pass any places of worship regardless of denomination.

A copy of emails received from this Objector are set out in **Appendix 3** to this report.

## 3. Objector 3

This Objector has objected as follows:

Objection to the proposed route to Shore Street, Princes Street, John Wood Street and Fore Street.

Proposed alternative route of Boglestone, Ardmore Road, Springhill and Balfour Street/Brown Street, Lower Mary Street and Ardgowan Street.

The parade is on a Saturday, the busiest day of the week for local traders. The parade will cause disruption to local people and commuters. Public transport and traffic delays will occur through the town centre.

A copy of emails received from this Objector are set out in **Appendix 4** to this report.

## 7.0 RESPONSE OF APPLICANT

7.1 The applicant has been advised of the objections but has verbally indicated he is unwilling to alter the timing or route of the parade. No written response has been received by the applicant.

## 8.0 LEGAL POSITION

8.1 In terms of section 63 (8) (a) of the Civic Government ( Scotland ) Act 1982 the grounds upon which a local authority may prohibit or impose conditions on the holding of a parade are as follows:

- Public Safety
- Public Order
- Damage to Property
- Disruption to the life of the Community ( e.g. closing of roads, rerouting of bus services, closure of shops, limited access for the community to the streets for a period of time).

8.2 Article 11 of the European Convention on Human Rights makes it clear that there is a right to assemble and to process in a public place. Freedom of peaceful assembly is a fundamental human right which can be enjoyed and exercised by individuals and groups. No restrictions shall be placed on the exercise of these rights other than such as are

prescribed by law and are necessary in a democratic society in the interest of national security or public safety, for the prevention of disorder or crime, for the protection of health and morals or the protection of rights and freedoms of others.

The parade route has been examined and appears to be in order. However, there is some likelihood of disruption to pedestrian and vehicular traffic should the parade go ahead.

The applicant was spoken to on 12/05/22 and has agreed to the following:

1. The provision of 9 stewards escorting the parade along the length of the route, all of whom will be distinguishable by high visibility clothing. This achieves the preferred stewarding ratio.
2. To make participants aware of street furniture on the route, which may prove to be a hazard.
3. No music shall be played whilst passing any place of worship whilst services are in progress.
4. The applicant will be present and in charge of the parade.
5. The parade will not start without the presence of the police.
6. All police instructions must be followed.

(Comments / Observations):

The Chief Constable, as a statutory Consultee to the Local Authority in connection with this proposed procession, submits the foregoing for consideration by the Authority. I am, on behalf of the Chief Constable, ready to attend any meeting which the Authority might arrange with those proposing to hold the procession to make further representations in support of this submission.

The Chief Constable recognises that should an appeal be marked to the Sheriff against a decision prohibiting a procession, or a decision imposing conditions on a procession, that there is no express, legislative requirement that the Chief Constable be convened as an interested party to such an appeal. Nonetheless, and in accordance with the Guidance for Scottish Local Authorities issued by the Scottish Ministers in terms of Section 65 (A) of the 1982 Act, the Chief Constable expects to be consulted by the Local Authority in connection with any decision which is reached or prohibiting a procession or placing conditions on it. That expectation would continue in the event of an appeal being marked to the Sheriff and particularly so in the event that the Authority contemplates reaching agreement with an Appellant to concede that a prohibited procession instead to be allowed to go ahead and / or alternate wording for any condition(s) to be put in place.

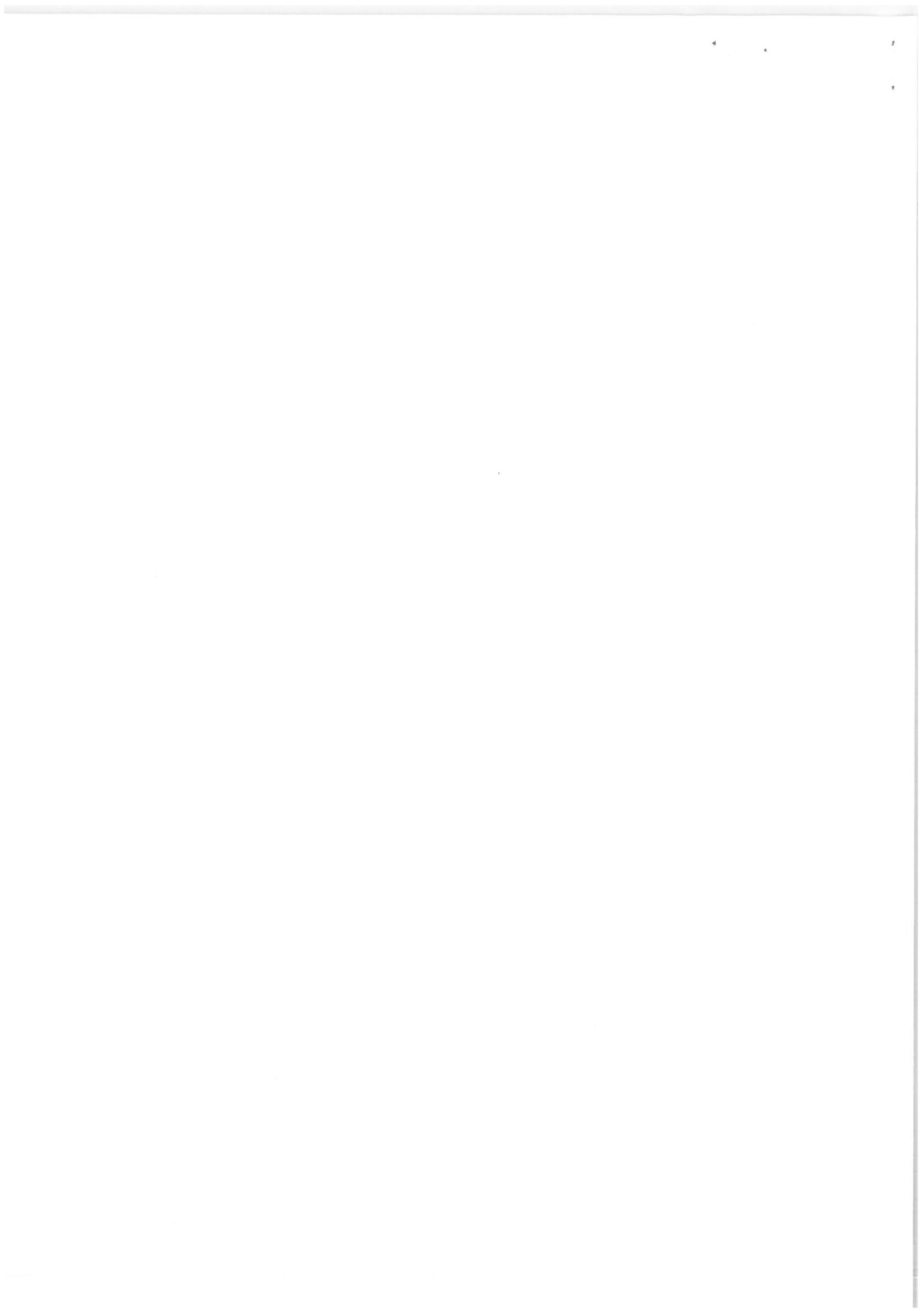

Good day Emma, and Local Councillor's.

I'm writing to you in response to the notification I received with regards to a parade/procession being held by the Local Orange Order in Port Glasgow on Saturday July 2nd of this year.

While I respect all people of Port Glasgow have the right to have a parade/procession, I believe, as I've said before, you must also respect the rights of the people of Port Glasgow to go about the daily business without interruption, or distress.

My opposition in this case is about the timing of the event, and the route being taken. They will leave Ardmore Road at 8.45am to walk to Port Glasgow town centre. At 9.30am every morning there is a celebration of Holy Mass in St John the Baptist on Shore Street. I believe that this parade/procession will pass the Church, either just prior to the beginning of Mass (when a lot of older people are making their way to Church) or just after Mass has started.

Similarly on the return journey. They will set off on Marloch Avenue at 5.30pm, Holy Mass is celebrated at 5pm every Saturday evening in St Francis of Assisi RC Church, which means it will pass the Church near the end of Mass, or just as the parishioners are exiting the Church.

I've said this in the past on a few occasions. No parades/processions should be allowed to pass any place of worship, at least 30 minutes before or after any scheduled service. I suspect the timing of these events has been set to coincide with the services in these two aforementioned RC Churches.

Finally, I believe that the timing of these parades/processions should be altered, or that the routes should be altered, in order to protect the many elderly members who attend both St John's and St Francis, (some on a daily basis) from any alarm or distress that could be caused.

I'll be very interested in the opinions of the recently elected Councillors, as well as the legal department.

Yes; our objection still stands, that the Parade be re-routed to avoid: Shore St, Princes St, John Wood St, and Fore St.; to avoid disruption to the Port Glasgow public and Town Centre traders.
