Subject: UK Government Shared Prosperity Fund: Inverclyde Proposals

1.0 PURPOSE AND SUMMARY

1.1 ⊠For Decision □For Information/Noting

- 1.2 This report is to provide an update to Committee on Inverclyde Council and Glasgow City Region's progress with the UK Government's Shared Prosperity Fund (SPF). The report also seeks approval for the project proposals for Inverclyde.
- 1.3 Following engagement on a metropolitan region basis, the Regeneration Service has worked with internal and external stakeholders to make recommendation for inclusion of 23 projects to progress within the investment plan, 17 projects for core SPF and 6 projects for Multiply, which along with admin costs, allocates the full SPF budget of £3,563,931.
- 1.4 The Regeneration Service has worked with the Glasgow City Region to prepare the investment plan which was approved by the UK Government on 5 December 2022.

2.0 RECOMMENDATIONS

- 2.1 It is recommended that the Committee:
 - a) Approve the project proposals for Inverclyde;
 - b) Delegate to the Director Environment & Regeneration the authority to enter into the grant agreement with Glasgow City Region;
 - c) Delegate to the Director Environment & Regeneration the authority to enter grant agreements with the project leads to deliver the approved projects.

3.0 BACKGROUND AND CONTEXT

- 3.1 The UK Shared Prosperity Fund is a £2.6bn fund for local investment, with all areas of the UK receiving an allocation of funding. This fund is a central pillar to the UK Government's Levelling Up agenda and replaces European Structural Funds which will operate until December 2022. Inverclyde has benefitted from a range of European Structural Fund programmes which have focussed on people and place.
- 3.2 As previously reported, Inverclyde is part of the Glasgow City Region Investment Plan which was submitted to the UK Government at the end of August 2022 and was approved by the UK Government on 5 December 2022.
- 3.3 At the June and August Environment and Regeneration Committees it was reported that Inverclyde has a total allocation of £3,563,961 (Core SPF £2,948,498 and Multiply £615,463) and that Inverclyde Council would work with the Glasgow City Region to prepare a region Shared Prosperity Investment Plan. Officers from the Regeneration Service have worked extensively with colleagues across the metropolitan city region to develop proposals which were included in the Investment Plan.
- 3.4 Highlights of the outcomes and outputs of proposals were presented to the Environment and Regeneration Committee in August.
- 3.5 The Regeneration Service carried out a call for project ideas with internal and external stakeholders. A total of fifty-two project proposals were received from a variety of internal and external partners.
- 3.6 Following this, the submissions were assessed, creating a long list and then a short list of projects. The short list projects were then asked to develop more detailed project proposals to provide assurance that they were deliverable, and where appropriate match funding was detailed.
- 3.7 Each project was evaluated against the eligibility criteria developed and officers' recommendations for progression are set out below, with 17 projects for core SPF at a total cost of £2,821,958 and 6 projects for Multiply at a cost of £590,844.
- 3.8 Shared Prosperity is a fund that runs from 2022-2025, however, as the Investment Plan was only approved in late 2022 the UK Government agreed that the funding for 2022-2023 could be accrued into year 2 2023-2024.
- 3.9 Given the time delay, the Regeneration Service has re-evaluated projects ensuring that they fit with the current needs of Inverclyde, aligning with the emerging findings from the Inverclyde Taskforce. In addition, the Regeneration Service has worked with project leads to update proposals, spend profile and proposed deliverables. Year 1 funding can be carried over to year 2 however a 'credible plan' is required to show that the spend can be achieved. Through the work with project leads the project spend has been re-profiled, in line with the UK Government requirements.

4.0 Proposals

4.1 The table below sets out project recommendations for 2023-2025. Further information on the project is within appendix 1.

^{4.2} Part of SPF, 4%, is allowed for management costs for monitoring and evaluation of the projects. It is intended that Inverclyde Council will use the fee to fund 1.3 FTE posts.

4.3 There is one project that is being delivered by Glasgow City Region. The Clyde Climate Forest aims to plant 18 million trees planted across urban and rural areas of the city region, delivering ecological and climate benefits. The contribution from Inverclyde's Shared Prosperity is £8600. The project will be managed by the GCR therefore the detail is not included in the table above as there are no monitoring or reporting requirements for Inverclyde Council.

Grant Agreements and Payments

- 4.4 Following the approval of the Investment Plan, UK Government has entered into an agreement with Glasgow City Council who is the Lead Authority representing the Glasgow City Region. An agreement will then be entered into between Glasgow City Council (on behalf of the City Region) and Inverclyde Council. Inverclyde Council will then issue agreements to project deliverers and the Council, will be responsible for monitoring and assurance of local activity.
- 4.5 Funding will be issued to the member authorities following signing of the grant agreement with the Glasgow City Region and agreement of the assurance framework. The Member Authorities have worked together on this framework to ensure that there is consistency across the region. The draft grant agreement and assurance framework have been reviewed by the Regeneration, Finance and Legal services ahead of them being formally received by the Council.
- 4.6 As stated above, the UK Government have confirmed that year 1 funding can be carried over to the subsequent financial year however, all or part of the subsequent years grant will be held back until full spend for that financial year has been achieved or there is a credible plan of how it will be spent. The Regeneration Service is working with Glasgow City Region to update the Investment Plan to form the 'credible plan', which for Inverclyde, is based on the project proposals in this paper.
- 4.7 Year 3 24/25 funding will be issued when the UK Government is satisfied that the previous year's tranche has been adequately spent. All funds must be spent by March 2025.
- 4.8 Inverclyde Council's will enter into funding agreements with project leads. The Regeneration Service has consulted with Legal Services and grant agreements will be made for each project which will 'pass down' the requirements from UK and GCR to the project leads.
- 4.9 It has been agreed, through discussion with the Finance Service, that grants shall be paid to project leads in arrears following the submission of a grant claim form accompanied by suitable evidence of eligible spend.

Monitoring, Reporting and Assurance

- 4.10 With regards to reporting, the UK Government have set out requirements for quarterly and sixmonthly report. As we are working with the Glasgow City Region, Inverclyde Council will prepare local report, which require to be signed off by the Chief Financial Officer, and then submitted to the Glasgow City Region. The Glasgow City Region will then submit the reports to the UK Government following sign off by the Chair of the Finance Strategy Group.
- 4.11 The Glasgow City Region SPF Lead Officers Group have worked together to prepare the assurance framework of the Glasgow City Region. It will be for us as a Council, and in particular, the Regeneration Service, to ensure that the relevant checks are made, in line with the assurance framework, for each project to ensure that activities and spend is eligible against the SPF grant and what they have set out in the proposal.

4.12 Inverclyde will monitor the projects. Applicants will be required to submit evidence to the Council demonstrating progress towards achievement of project targets at which meet reporting requirements of the GCR and UK Government. This will include both qualitative and quantitative data. The level of information will be set out in the project funding agreements between the Council and project leads. To ensure that monitoring is coordinated the management fee will be used to employ 1 person, and a Monitoring Officer within the Regeneration Service has been identified to support the Regeneration Manager with monitoring, reporting and assurance. The team will ensure that there is regular contact with the project leads and ensure that reporting deadlines are met, claims are checked, and payments made timeously.

Next Steps

- 4.13 The Regeneration Service will continue to liaise with Legal and Finance on the pass-down grant agreement from Glasgow City Region. They will also liaise with Legal on the preparation of agreements for the project leads.
- 4.14 The Regeneration Service will ensure that the required monitoring, reporting and assurance is carried out, in consultation with Finance and Audit services, and submit to the Glasgow City Region.
- 4.15 The Regeneration Service to advertise for the 1 FTE timeously to support the service with required monitoring, reporting and assurance.
