- 1.2 This report provides Members with an update in respect of the use of funds from allocations made by the Scottish Government under the headings of the Town and Village Centre Funds alongside Place Based Funding initiatives.

#### 3.0 BACKGROUND AND CONTEXT

- 3.1 Since 2016 Inverclyde has benefitted from town and village centre funding and latterly Place Based Funding.
- 3.2 In the early stages of the programme projects were administered by Riverside Inverclyde. In recent years the funds have been administered by the Environment and Regeneration Directorate.
- 3.3 In order to increase the scale of projects undertaken and to simplify the governance process officers have led the programmes rather than placing a burden on the goodwill of the Town Centre Regeneration Forums.
- 3.4 It is recognised that the annual allocation of funding has not resulted in projects of scale however with a multi year award of £407,000 funding over the next three years it is officers intention to bring a report to the next cycle of the Committee.
- 3.5 Whilst most projects are complete a number of legacy projects remain outstanding, these will be expedited as soon as possible.
- 3.6 Port Glasgow, Greenock and Gourock have benefitted from largest allocation of funds however all of the villages have benefitted too. The total funding allocated is £5.3m.
