There was submitted a report on the performance and activities of the Scottish Fire & Rescue Service during the reporting period 1 April 2023 to 30 June 2023. During discussion on this item reference was made to the increase in deliberate fire setting particularly in relation to refuse and grassland fires being the main contributors. Group Commander Anderson advised that the Scottish Fire & Rescue Service Community Action Team are working with partners across Inverclyde taking a targeted approach to reducing deliberate fire settings. Area Commander McCarrey provided assurance that there are plans in place should there be a major incident following concerns raised by Members in relation to deliberate fire settings throughout Inverclyde and the recent fire at the derelict school at Robert Street, Port Glasgow.

Decided: that the information contained in the report be noted.

469 Police Scotland Performance Report

469

Prior to the discussion on this item Chief Superintendent Waddell provided Members with a further update on the national picture in relation to the reduction in police officer numbers and the challenges of the service. She further advised that a report had been submitted to Scottish Government by Police Scotland and the Scottish Police Authority regarding the impact if Police Scotland are continually underinvested. Members were advised that the link to the paper would be circulated. Thereafter, Chief Superintendent Waddell answered a number of questions from Members.

There was submitted a report on the performance and activities of Police Scotland during the reporting period 1 April 2023 to 31 July 2023. During discussion of this item Chief Inspector Kane made reference to missing person reports in Inverclyde during the reporting period. It was noted that 84 missing person reports were recorded, an increase of 20% on the same reporting period in 2022. Chief Inspector Kane informed Members that missing persons reports have been particularly significant amongst people under the age of 19. It was noted that repeat missing person reports continue to be an issue of concern, particularly in relation to Looked After and Accommodated Children. He further advised that Police Scotland colleagues are working with partner agencies in order to address this issue. Chief Inspector Kane advised Members that road casualties have increased in the reporting period with more people seriously or slightly injured on Inverclyde's roads. It was noted that the Road Policing unit has contributed to a rise of 19.8% in the recording of road traffic offences which include speeding, mobile phone, licence and insurance offences. Chief Inspector Kane reported that six suspected drug deaths occurred in Inverclyde in the reporting period. He informed Members that 108 officers deployed in Inverciyde have completed Naloxone training. It was noted that intelligence led policing resulted in 14 drug supply detection cases during the reporting period and that organised criminals in Renfrewshire & Inverclyde were deprived of £808,553 in cash and assets through use of the Proceeds of Crime Act.
