1.0 PURPOSE AND SUMMARY

- 1.2 The Scottish Government has awarded funding for financial year 2023-24 and has given an in principle allocation for 2024-2025 and 2025-2026.
- 1.3 This report sets out projects that are proposed for 2023-2024 for approval.
- 1.4 The report also sets out indicative projects and costs for 2024-2025 and 2025-2026 in principle allocations.

2.0 RECOMMENDATIONS

- 2.1 It is recommended that the Committee:
 - Approve the projects for 2023-24
 - Note the suggested projects for 2024-2025 and 2025-2026 and that reports for approval will be presented to the Environment and Regeneration Committee when funding is confirmed.

3.0 BACKGROUND AND CONTEXT

- 3.1 The Scottish Government committed to the Place-Based Funding Investment Programme through the 2020 Programme for government. The aim of the fund is to ensure that all place based investments are shaped by the needs and aspirations of local communities and accelerate ambitions for place, 20 minute neighbourhoods, town centre actions, community led regeneration and community wealth building. The Place Principle underpins the approach.
- 3.2 The Scottish Government and Council Leaders have agreed that Local Government will receive a share of the funding, from the Place Based Investment Programme, over 5 years to support and advance place-based investment.
- 3.3 As part of that the Scottish Government have awarded the funding for 2023/24 and provided in principle allocations for 24/25 an 25/26.
- 3.4 Inverclyde Council has been awarded £407,000 for 23/24 and has an in principle allocation of £407,000 in 24/25 and £407,000 in 25/26.

4.0 PROPOSALS

4.1 The table below set out projects proposed for 2023-2024:

Customhouse Quay Clock Restoration	Refurbishment of the clock in Custom House Square. This project is partially funded through PBF and other Council funding sources.	2023- 2024	£120,000
Customhouse Quay Square Restoration Phase 1	Improvement of the square improving the cobbles etc with this phase concentrating on the main route from the town centre to the waterfront, along the western side of the square. This project is partially funded through PBF and other Council funding sources.	2023- 2024	£170,000
Dunrod Road, Phase 1	Contribution towards improvement works to re-open the road and improve connectivity between the urban and rural areas of Inverclyde. This project is partially funded through PBF and other Council funding sources.	2023- 2024	£100,000
Kempock Place Kiosk	Upgrade the Kiosk to allow use by community or business groups	2023- 2024	£17,000

- 4.2 The criterion for the funding allows for funding to be carried over to September 2024, as long as projects are fully committed by March 2024. The Capital Programme earlier on this agenda currently shows some slippage within the Place Based Funding to reflect this.
- 4.3 As funding has been agreed in principle for 2024-25 and 2025-26, projects have been indicatively put forward for these years. It should be noted that, as this funding is indicative only, at this stage it is not included in the Capital Programme. The Scottish Government could reduce funding or other priorities may come forward between now and the start of projects. Projects will be refined

and reports will be presented to Environment and Regeneration Committee prior to the commencement of the respective financial years for approval of projects.
