Subject: Warm Hand of Friendship Grants 2024/25

#### 1.0 PURPOSE AND SUMMARY

1.1 □ For Decision □ For Information/Noting

- 1.2 The purpose of this report is to update the Committee on the successful applications for funding through the Warm Hand of Friendship Initiative for 2024/25.
- 1.3 The Warm Hand of Friendship fund, initially set up in 2022 with £100,000 from the Inverclyde Council Anti-Poverty Budget, aims to support local community organisations in Inverclyde. The initiative helps these organisations deliver essential services to their communities, particularly during the colder autumn and winter months. By focusing on grassroots activities, the initiative provides local organisations with an opportunity to better understand and address the specific needs of their communities.
- 1.4 Inverclyde Council has supported the Warm Hand of Friendship initiative in both the 2022-2023 and 2023-2024 winter periods, assisting around 50 local community organisations per year to deliver services such as safe warm spaces, meal provision, and community activities.
- 1.5 In September 2024, the Policy and Resources Committee approved an additional £120,000 per year to fund the initiative through to March 2027.
- 1.6 As part of this funding round, 53 organisations have successfully applied for grants of up to £3,000 each. These grants will be used to provide food, warmth, and safe meeting spaces for people in their local communities or with shared community interests.

#### 3.0 BACKGROUND AND CONTEXT

- 3.1 The Warm Hand of Friendship fund, established in 2022 with £100,000 from the Inverclyde Council Anti-Poverty Budget, aims to provide financial support to local community organisations. This initiative seeks to deliver support for grassroots services that cater to the unique needs of communities during the winter months, offering opportunities for local organisations to connect with and understand the people they serve.
- 3.2 During the 2023-2024 winter period, the Warm Hand of Friendship initiative supported 58 local community organisations, enabling them to provide vital services such as warm spaces, food, clothing, and community activities.
- 3.3 In September 2024, the Policy and Resources Committee agreed to continue funding the initiative through March 2027, with an additional £120,000 allocated annually from the Council's Anti-Poverty fund
- 3.4 To strengthen the governance of the initiative, additional scrutiny has been applied to the funding process from 2024. Applications for funding must now align with other grant processes such as the Community Grants Fund, and financial awards cannot exceed £3,000 per organisation. In addition, applications are assessed by a team of senior officers.

To qualify, organisations must meet the following criteria:

- Actively deliver services in Inverclyde;
- Be a non-profit entity with Public Liability Insurance (where applicable);
- Have a constitution, set of rules, or Memorandum and Articles of Association, signed and adopted by an office bearer;
- Hold a bank or building society account requiring at least two signatures for cheque or withdrawal; and
- Ensure the grant is spent within one year of the award date.
- 3.5 To increase community engagement in the process, a pilot programme to use the Council's Community Choices platform was introduced in 2024. Each organisation was required to upload their planned activities for feedback on the Council's Community Choices platform. 253 community members commented on the platform their view on the impact and outcomes of these initiatives which provided the assessment panel with some community opinion on the planned initiatives. An evaluation of this approach will be undertaken following the allocation of the second round of applications early in 2025.

## 4.0 DETAILS OF AWARDS

- 4.1 Following assessment, a total of 53 local organisations were awarded a total of £83,940 in funding. Four further organisations did not meet the governance criteria or are being asked to provide further information. Details of all applications, a brief summary of their planned initiative and their funding allocations are set out in Appendix 1. A balance of £36,000 remains, and another round of applications will be sought in January 2025.
- 4.2 A further review of the impact and outcomes of the Warm Hand of Friendship initiative will be presented to the Education and Communities Committee later in 2025.
