3.0 BACKGROUND AND CONTEXT

- 3.1 The membership of the Inverclyde Alcohol and Drugs Partnership was agreed at the Statutory Meeting of the Council on 19 May 2022 as being: the Convenor of the Social Work & Social Care Scrutiny Panel (now Councillor Brennan), Chair of Inverclyde Licensing Board (Councillor Brooks), and (3) Councillor Armstrong.
- 3.2 Pursuant to Standing Order 59, the Council shall ensure that appointments to its Committees and Outside Bodies reflect, as far as practicable, the balance of political representation on the Council where two or more representatives of the Council are required.
- 3.3 The SNP Group has proposed a change to the SNP representation on the Inverclyde Alcohol and Drugs Partnership so that Councillor Armstrong will be replaced by Councillor Daisley. As this is a change within the SNP Group, political balance is unaffected by this proposed change.
