There was submitted a report by the Head of Organisational Development & Human Resources recommending that the pay offer for 2008 - 2010, which had been accepted by the trade union Unison but rejected by the GMB and Unite the Union, be applied for 2008 - 2010 with immediate effect.

Decided: that the pay offer of 3% for the first year 1 April 2008 to 31 March 2009 and 2.5% for the following year 1 April 2009 to 31 March 2010 be processed in advance of the agreement of all three trades unions.
