736 Presentation by Max Hislop of the Glasgow and Clyde Valley Green Network

The Committee heard a presentation by Mr Max Hislop, Programme Manager for the Glasgow & Clyde Valley Green Network, a 20 year programme which will link paths, walkways, woodlands and countryside along miles of path and cycle routes bringing a range of social, economic and environmental benefits to the Glasgow Metropolitan region. Following the presentation, Mr Hislop answered a number of questions from Members.

746 Proposed Traffic Regulation Order - On-Street Parking Places (Without Charges) Order No 2 2008

747 Proposed Traffic Regulation Order - Craigends Bridge, Kilmacolm (13 Tonne Weight Restriction Revocation) Order 2008

748 Planning Policy and Housing: Update on Work Programmes and Issues Arising

- (2) that the Committee endorse the revised work programmes of both the Planning Policy and Housing teams due to the requirement to have close integration in the preparation of these key plans and strategies over the next 2-3 years;
- (3) that approval be given to the use of the Service's budgeted resources for the first year of a Glasgow and the Clyde Valley Housing Needs and Demand Assessment to be undertaken by the eight Local Authorities comprising the Strategic Development Planning Authority; and
- (4) that the Committee's congratulations be extended to Mr Fergus MacLeod following his nomination as Chair of the Glasgow and the Clyde Valley Housing Needs and Demand Assessment Technical Group and to Mr Fraser Williamson who will represent COSLA and the Scottish Society of Directors of Planning on the Steering Group established by the Scottish Government to examine the delivery of housing needs and to foster closer links between housing and planning.
