Subject: Sports Pitches Action Plan Update - George Road, Gourock

#### 1.0 PURPOSE

1.1 The purpose of this report is to request the Committee to consider a remit from the Regeneration Committee.

#### 2.0 SUMMARY

2.1 The Regeneration Committee at its meeting on 12 March 2009 considered the attached APPENDIX report by the Corporate Director Regeneration & Resources seeking approval of an updated Sport Pitches Action Plan.

## 2.2 The Committee decided:-

- (1) that the Committee endorse the approach taken in terms of pitch prioritisation;
- (2) that the Sports Pitches Action Plan update which recommends that the first tranche of funding of £500,000 for 2009/10 be used to upgrade the Broomhill blaes pitch to a 3G Fieldturf Pitch with appropriate floodlighting and fencing be approved, it being noted that changing accommodation will be provided as funds become available;
- (3) that approval be given to the acceleration into 2009/10 of a second 3G Fieldturf Pitch at George Road, Gourock to be funded by the Scottish Government's Capital Acceleration Grant and that the financial implications be remitted to the next Policy & Resources Committee;
- (4) that authority be delegated to the Corporate Director Regeneration & Resources to select appropriate tenderers and to issue tender documents for the delivery of two synthetic football pitches and to accept the lowest and most economically advantageous tender in accordance with the Council's Standing Orders and Financial Regulations; and
- (5) that it be remitted to the Corporate Director Regeneration & Resources to bring forward proposals as soon as practicable for the allocation of the remaining funding for sports pitches for 2010-2014 in line with the approach endorsed in (1) above.

## 3.0 RECOMMENDATION

3.1 The Committee is asked to consider the remit from the Regeneration Committee relative to George Road, Gourock.

**Update** 

### 1.0 PURPOSE

1.1 The purpose of this report is for Committee to approve an updated Sports Pitches Action Plan in light of the Council's recent announcement to invest £3.0m in sports pitches over the next 5 years.

### 2.0 SUMMARY

- 2.1 The Inverciyde Sports Strategy was approved by the previous Council's Community Committee in March 2007 and part of the Strategy included an assessment of pitches in Inverciyde. The Sports Pitches Action Plan was written by the Council's Sports Strategy Group after consultation with Sport Scotland and a number of Sports' Governing Bodies and was approved by the Regeneration Committee on 4<sup>th</sup> September 2008.
- 2.2 The Council, as part of its budget announcements, has approved the investment of £3.0m in Sports Pitches over the next 5 years with the first tranche of funding of £500,000 due to be spent during the 2009/10 financial year. The Sports Pitches Action Plan Update, attached at Appendix A, sets out on a pitch by pitch basis the recommendations for investment in 2009/10 along with further considerations for the allocation of the future funding up to March 2014.

### 3.0 RECOMMENDATIONS

- 3.1 It is recommended that Committee:
  - a. endorses the approach taken in terms of pitch prioritisation.
  - b. approves the Sports Pitches Action Plan Update which recommends that the first tranche of funding of £500,000 for 2009/10 should be used to upgrade the Broomhill blaes pitch to a 3G Fieldturf Pitch with appropriate floodlighting and fencing noting that changing accommodation will be provided as funds become available.
  - c. approves the acceleration into 2009/10 of a second 3G Fieldturf Pitch at George Road, Gourock to be funded by the Scottish Government's Capital Acceleration Grant and that the financial implications be remitted to the next Policy and Resources Committee.
  - d. delegates authority to the Corporate Director Regeneration and Resources to select appropriate tenderers and issue tender documents for the delivery of 2 synthetic football pitches and accept the lowest or most economically advantageous tender in accordance with Council Standing Orders (General) and Financial Regulations (26.5).
  - e. remits the Corporate Director Regeneration and Resources to bring forward proposals as soon as practicable for the allocation of the remaining funding for sports pitches for 2010-2014 in line with the approach endorsed in Para 3.1.

#### 4.0 BACKGROUND

- 4.1 The Community Committee at its meeting in March 2007 approved the Inverclyde Sport Strategy and remitted the Corporate Director Regeneration and Resources to lead its implementation.
- 4.2 The Sports Strategy Group has as one of its actions to progress a Sports Pitches Action Plan for Inverclyde and this was approved by Committee on 4<sup>th</sup> September 2008.
- 4.3 The previous version of the Sports Pitches Action Plan, approved by the Council in September 2008, identified that the priority for action was for improved drainage for Ravenscraig Stadium and for a new 3G pitch at Lady Octavia. The Lady Octavia Pitch has recently been completed and the Ravenscraig pitch will have its drainage improved in June 2009. No further recommendations were made because no further funding was identified at that time. In light of the Council's recent announcements to invest a further £3.0m over the next five years the Sports Pitches Action Plan has been updated and is attached at Appendix A.
- 4.4 The revised Action Plan for the analysis of pitches in the area has taken into consideration many aspects including:
  - Other pitches and sports/community facilities in the vicinity
  - The surface of the current pitch
  - Drainage considerations
  - Changing accommodation
  - The socio economic profile of the area
- 4.5 The Action Plan also takes into consideration the future provision of grass, 3G, 2G and blaes pitches, including the provision within schools. After consultation with Sport Scotland and the Governing Bodies for Football, Youth Football, Junior Football, Hockey and Rugby the following conclusions have been drawn.
  - From a playing point of view the preferred surface for most teams is grass however this limits the number of games that are able to be played to 2 per week. On an exceptional basis this could be increased to 3 per week.
  - 3G offers the best synthetic surface options in terms of its playing properties and would significantly increase the number of games able to be played on the surface on a weekly basis.
  - 2G offers some qualities that are best suited to sports like hockey but are not recommended for competitive football matches.

Blaes pitches are not recommended by any sports Governing Bodies and need to be removed from the Council's portfolio of pitches as soon as possible.

- 4.6 Many of the pitches are affected by drainage issues, by phasing the works in the order identified in the action plan, it will allow for comprehensive drainage surveys to be completed allowing for appropriate schemes to be developed, in appropriate timescales.
- 4.7 It should be noted that a number of proposals identified in Appendix A (Parklea and George Road) allows for the provision of a single 3G Fieldturf facility in lieu of 2 or more blaes pitches. This particular approach is currently subject to discussion with SportScotland and a verbal update on its opinion will be provided at Committee.

## 5.0 PROPOSALS

5.1 The proposal for the initial £500,000 phase of funding during 2009/10 is that this is used to upgrade the Broomhill Blaes Pitch to a 3G Fieldturf Synthetic Pitch, associated floodlights and fencing (costings subject to detailed design) with changing to follow as funds within the £3.0m become available.

- 5.2 Broomhill has been recommended for the initial phase of funding because it matched in well to the above criteria as follows:
  - There are very few sports/community facilities in the area
  - The surface of the current pitch is blaes and must be replaced
  - The current pitch has reasonably good drainage and this will keep the cost of the redevelopment down
  - The current changing accommodation badly needs replaced
  - The Broomhill Area is one of the areas of Inverclyde with the greatest regeneration needs
- 5.3 Members should also note that the Scottish Government has announced it is allowing local authorities to bring forward expenditure from 2010/11 into 2009/10. In this regard, it is proposed that expenditure in the order of £450,000 be brought forward to fund a second 3G Fieldturf Pitch at George Road, Gourock. The total cost of this project is estimated to be in the region of £500,000, but is subject to detailed design. George Road has been recommended for accelerated funding because it can be delivered within the timescales.
- 5.4 Initial estimated revenue implications are given below however further work will be required to finalise this information.

The maintenance cost figures assume the following:

- 1. Only the pitch maintenance has been costed. Services such as litter picking, emptying of bins, brushing surrounds, brushing lines, changing pitch layout etc. have all not been included at this stage.
- 2. The purchase of mini tractor and associated equipment as part of the capital cost of the project.
