1.0 PURPOSE

1.1 The purpose of this report is to give details of applications received for consideration of funding from the Grants to Voluntary Organisations Budget in 2009/10.

2.0 SUMMARY

- 2.1 The Budget for the Grants to Voluntary Organisations Fund for 2009/10 is £401,780.
- 2.2 Round 1 of applications in 2009/10 resulted in awards totalling £329,900 to local groups leaving a balance still to be awarded of £71,880.
- 2.3 Round 2 of applications in 2009/10 resulted in awards totalling £32,095 to local groups leaving a balance still to be awarded of £39,785.
- 2.4 Details of the grants applications received for Round 3 are given in Appendix A. In total 26 applications have been received with a total sum requested of £279,210.
- 2.5 Further information on each application is available on request and will also be available at the Sub-Committee Meeting.
- 2.6 In Round 1, the Waivers to Let Budget received a contribution of £18,000. It is proposed that any underspend after Round 3 should be allocated to the Waivers to Let Budget to offset any potential overspend in this budget.

3.1 That the Grants Sub-Committee considers the level of funding to be allocated to the projects in Appendix A.
