Subject: Development Management Performance

1.0 PURPOSE

1.1 This report advises on the performance of the Development Management Team working within the Regeneration and Planning Service.

2.0 SUMMARY

- 2.1 The principal aim of the Development Management Team is to consider planning applications, seeking to ensure that development is undertaken in accordance with national and development plan policies and in the interests of the community as a whole. In 2009-10 402 planning applications were determined, generating a fee income of £221,050. While application numbers increased by 81 (20.1%) from 2007-8, fee income dropped by £99,555 as the number of larger fee generating proposals declined.
- 2.2 Planning applications contribute significantly to the local economy. The Development Management team add value to the process by ensuring that applications are determined promptly and, where appropriate, changes to proposals are negotiated to ensure high quality development and a low refusal rate.
- 2.3 Scottish Government Planning Performance Statistical Data for 2008-09 has been published. The planning application determination time indicator is recognised as the key measure of overall performance. Inverclyde Council determined 72.6% of all applications within 2 months, which is 12.1% above the national average and places Inverclyde as the 6th top performer. For the 3 month period, Inverclyde Council determined 85.6%, 10.9% above average and 5th placed. Inverclyde Council's approval rate is 95.8% and is the 6th highest in Scotland and leads the rate for predominantly urban councils. In 13 of the 14 measured performance indicators Inverclyde Council performs above average. In 8 of the indicators Inverclyde Council are in the upper quartile of the performers.
- 2.4 As a consequence of the Government's modernising planning agenda, the composition of statistical returns has changed. Where comparison can be drawn, figures for 2009-10 indicate that performance has improved, although at this stage figures are not available to allow comparison with other authorities.

3.0 RECOMMENDATION

3.1 It is recommended that the Committee notes the position.

4.0 BACKGROUND

4.1 The principal aim of the Development Management team is to consider planning applications, seeking to ensure that development is undertaken in accordance with national and development plan policies and in the interests of the community as a whole. While application numbers increased by 81 (20.1%) from 2007-8, fee income dropped by £99,555 as the number of larger fee generating proposals declined.

5.0 PERFORMANCE

- 5.1 Scottish Government Planning Performance Statistical Data for 2008-09 has been published. The planning application determination time indicator is recognised as the key measure of overall performance. Inverclyde Council determined 72.6% of all applications within 2 months, which is 12.1% above the national average and places Inverclyde as the 6th top performer. For the 3 month period, Inverclyde Council determined 85.6%, 10.9% above average and 5th placed. Inverclyde Council's approval rate is 95.8%, and is the 6th highest in Scotland and leads the rate for urban dominated councils. In 13 of the 14 measured performance indicators Inverclyde Council performs above average. In 8 of the indicators Inverclyde Council are in the upper quartile of the performers.
- 5.2 Figures for 2009-10 indicate overall performance improvement, although at this stage figures are not available to allow comparison with other authorities. In some cases direct comparison with previous returns is not possible due to changes to application categories following changes introduced by the Planning etc. (Scotland) Act 2006.
- 5.3 The Scottish Government Planning Performance Statistical Data for 2008-9, with available data for 2009-10 for comparison, is detailed as follows:

All major planning applications determined within 4 months:

Inverciyde 57.1% National average 28.1% Position 5th 2009-10 58.8%

All minor planning applications determined within 2 months:

Inverclyde 31.3% National average 33.9% Position 20th 2009-10 n/a

All major business and industry planning applications determined within 4 months: Inverclyde 66.7% National average 46.0% Position 6th 2009-10 n/a

All minor business and industry planning applications determined within 2 months: Inverclyde 73.0% National average 52.5% Position 4th 2009-10 n/a

All other major planning applications determined within 4 months: Inverclyde 92.3% National average 47.7% Position 4th 2009-10 n/a

All other minor planning applications determined within 2 months: Inverclyde 78.5% National average 59.7% Position 2nd 2009-10 n/a

All telecommunication planning applications determined within 2 months: Inverclyde 66.7% National average 65.3% Position 16th 2009-10 n/a

All listed building and conservation area consent applications determined within 2 months:

Inverclyde 31.8% National average 30.9% Position 11th 2009-10 35.5%

All advertisement consent applications determined within 2 months:

Inverclyde 81.3% National average 74.0% Position 10th 2009-10 95.6%
