1.0 PURPOSE

1.1 The purpose of the report is to introduce Traffic Regulation Order – McCallum Crescent, Gourock (One Way Only) Order 2011.

2.0 **SUMMARY**

- 2.1 In order to improve road safety, the Safe, Sustainable Communities Committee at the meeting held on 18 January 2011 agreed that The Inverclyde Council be asked to make the Traffic Regulation Order McCallum Crescent, Gourock (One Way Only) Order 2011 in terms of the Road Traffic Regulation Act 1984.
- 2.2 The proposals have been advertised and no objections were received.
- 2.3 There are no legal or financial implications.

3.0 RECOMMENDATIONS

- 3.1 That a Resolution is made in the following terms.
- 3.2 THE INVERCLYDE COUNCIL, incorporated under the Local Government etc. (Scotland) Act 1994, RESOLVE TO MAKE as they HEREBY MAKE a Resolution under Sections 1(1), 2(1) and (2) and Part III of Schedule 9 of the Road Traffic Regulation Act 1984 to introduce one way driving in McCallum Crescent, Gourock all as detailed in a copy of the Order forming a supplement to the principal minute hereof, and that the Head of Environmental & Commercial Services and the Head of Legal & Democratic Services be authorised to take all necessary action in connection therewith.

The Inverclyde Council in exercise of the powers conferred on it by Sections 1(1), 2(1) and 2(2) and Part III of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Strathclyde Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

- 1. This Order may be cited as "The Inverciyde Council McCallum Crescent, Gourock (One Way Only) Order 2011" and shall come into operation on #########.
- 2. In this Order the following expression has the meaning hereby assigned to it:
 - "vehicle" unless the context otherwise requires means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along roads whether or not by mechanical power.
- 3. No person shall drive or cause or permit to be driven any vehicle on the lengths of road specified in Column 1 of the Schedule to this Order otherwise than in the direction specified in Column 2 of the said Schedule.
