#### 1.0 PURPOSE

1.1 The purpose of this report is to give details of applications received for consideration of funding from the commissioned element of the Grants to Voluntary Organisations Budget in 2011/12.

#### 2.0 SUMMARY

- 2.1 The Budget for the commissioned element of Grants to Voluntary Organisations Fund for 2011/12 is £194,250.
- 2.2 Over the last three years 16 organisations have benefitted from three year funding. A review of the funding has been carried out and the Regeneration Committee considered a report at it's meeting on 12<sup>th</sup> May 2011.
- 2.3 Details of the grants applications received are given in Appendix A. In total 26 applications have been received with the total sum requested being just over £300,000.
