Area Renewal and the Inverclyde Green Network - Case Studies

### 1.0 PURPOSE

1.1 To seek Committee approval of the proposal to extend the recently completed study "Area Renewal and the Inverclyde Green Network" by carrying out five case studies, utilising external funding provided by the Central Scotland Green Network.

### 2.0 SUMMARY

2.1 In July 2011 the Central Scotland Green Network offered funding of £35,100 to commission five case studies suggested in the Area Renewal and the Inverclyde Green Network document. This work is of a specialist nature, and will necessitate the use of consultants not on the Standing Restricted List.

## 3.0 RECOMMENDATIONS

## 3.1 That the Committee:

- 1. welcome the award of £35,100 of Central Scotland Green Network funding, and approve its use to carry out the five case studies highlighted in the main Study; and
- 2. delegate authority to the Corporate Director Regeneration & Environment to issue tenders to the firms identified in paragraph 5.2 of this report, and, in consultation with the Head of Legal and Democratic Services and the Chief Financial Officer, accept the most economically advantageous tender.

## 4.0 BACKGROUND

4.1 In February 2011 the final approved version of the "Area Renewal and the Inverclyde Green Network" document by ERZ Ltd was delivered to the Regeneration and Planning Service, who were acting as lead contact on behalf of a client group comprising Inverclyde Council, Riverside Inverclyde, River Clyde Homes and the Glasgow and Clyde Valley Green Network Partnership (GCVGNP). Each of the partners mentioned Min Ref: contributed £8,000 towards a total cost of £32,000, with the Inverclyde Council 13/01/09 contribution being approved by Committee to come from the Cleaner Greener Safer Para 33 Stronger budget.

- 4.2 The resulting document is highly innovative and has been very well received by the partners and the membership of the GCVGNP. It has been submitted for the Landscape Institute annual excellence awards by the commissioned consultant, with approval of the client group.
- 4.3 In recommending future actions, the study highlighted five potential case studies appropriate for more detailed study. These comprise three strategic links from waterfront to inland routes, from Central Greenock, Cartsburn and central Port Glasgow, and the concept of two neighbourhood parks in the Strone area and upper Port Glasgow.

## 5.0 PROPOSALS

- 5.1 A bid to the Central Scotland Green Network for funding to carry out these case studies has been successful, with £35,100 being awarded.
- 5.2 It is proposed to issue tenders to the following firms:
  - EDAW, Norloch House, 26 King's Stables Road, Edinburgh, EH1 2EU;
  - Halcrow Group Ltd, 16 Abercromby Place, Edinburgh, EH3 6LB;
  - Ironside Farrar, New Gayfield Chambers, 12 Gayfield Square, Edinburgh, EH1 3NX:
  - Land Use Consultants, 37 Otago Street, Glasgow, G12 8JJ; and
  - ERZ Ltd, 6 Aird's Lane, Glasgow, G1 5HU.

## **Financial Information**

5.3 External funding of £35,100 has been secured from the Central Scotland Green Network to facilitate these five case studies. There will be no financial cost to Inverciyde Council in carrying out these case studies, and a consultant experienced in masterplanning will be engaged to carry out the work.

## 6.0 IMPLICATIONS

6.1 **Legal:** approval will allow the use of consultants not currently included on the approved contractors list.
