Subject:	PROPOSED TRAFFIC REGULATION ORDER – CHESTER ROAD, YORK ROAD, GREENOCK (NO WAITING, NO LOADING AT ANY TIME) ORDER 2011	

1.0 PURPOSE

- 1.1 The purpose of the report is to introduce Traffic Regulation Order – Chester Road, York Road, Greenock (No Waiting, No Loading at any Time) Order 2011.

2.0 SUMMARY

- 2.1 In order to improve road safety, the Safe, Sustainable Communities Committee at the meeting held on 25 October 2011 agreed that The Inverclyde Council be asked to make the Traffic Regulation Order – Chester Road, York Road, Greenock (No Waiting, No Loading at any Time) Order 2011 in terms of the Road Traffic Regulation Act 1984.
- 2.2 The proposals have been advertised and no objections were received.
- 2.3 There are no legal or financial implications.

3.0 RECOMMENDATIONS

- 3.1 That a Resolution is made in the following terms.
- 3.2 THE INVERCLYDE COUNCIL, incorporated under the Local Government etc. (Scotland) Act 1994, RESOLVE TO MAKE as they HEREBY MAKE a Resolution under Sections 1(1), 2(1) and (2) and Part III of Schedule 9 of the Road Traffic Regulation Act 1984 to introduce No Waiting No Loading at any time at Chester Road and York Road, Greenock all as detailed in a copy of the Order forming a supplement to the principal minute hereof, and that the Head of Environmental & Commercial Services and the Head of Legal & Democratic Services be authorised to take all necessary action in connection therewith.

The Inverclyde Council in exercise of the powers conferred on them by Sections 1(1), 2(1) to (3) and Part IV of Section 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Strathclyde Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order.

1. This Order may be cited as "The Inverclyde Council Chester Road, York Road, Greenock (No Waiting No Loading at Any Time) Order 2011 and shall come into operation on #####.
2. In this Order the following expressions have the meanings hereby assigned to them:

"vehicle" unless the context otherwise requires, means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along roads whether or not by mechanical power;

"taxi" has the same meaning as in Section 23(1) of the Civic Government (Scotland) Act 1982;

"Council" means The Inverclyde Council;
3. Save as provided in Article 4 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait at any time in any of the lengths of road specified in Schedule 1 and plan annexed to this Order.
4. Nothing in Article 3 of this Order shall:
 - (a) Prevent any person from causing or permitting a vehicle to wait in any of the lengths of road referred to in that Article:-
 - (i) for so long as may be necessary to enable a person to board or alight from the vehicle or to load thereon or unload therefrom his personal luggage;
 - (ii) for so long as may be necessary to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of the road so referred to, or the laying, erection, alteration or repair in or near to any of the said lengths of the road, of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus as defined in the Telecommunications Act 1984;
 - (iii) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of statutory

powers and duties and in particular, but without prejudice to the generality of the foregoing, to enable the vehicle to be used in connection with police, fire brigade and ambulance purposes;

- (iv) if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid an accident;
 - (v) if the vehicle is in the service of or employed by the Post Office and is waiting in any of the lengths of the road while postal packets addressed to premises adjacent thereto are being unloaded from the vehicle or having been unloaded therefrom are being delivered or while postal packets are being collected from premises or posting boxes adjacent thereto;
 - (vi) for the purpose of loading or unloading the vehicle while the vehicle is standing at the kerb and is in actual use in connection with the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository;
 - (vii) to enable the vehicle to be used in connection with funeral operations.
- (b) Apply to a licensed taxi waiting in a taxi stance during any period for which that stance has been designated by the Council under the Civic Government (Scotland) Act 1982.

Length of Road In Inverclyde

Side of Road to which
Restriction Applies

York Road

From the extended northwest kerb line of Chester Road northwestwards for a distance of 7 metres or thereby

South

From a point opposite the extended southeast verge line of Chester Road northwestwards for a distance of 20 metres or thereby

North

Chester Road

From the extended southwest kerb line of York Road southwestwards for a distance of 34.5 metres or thereby

West

From the extended southeast kerb line of York Road southwestwards for a distance of 22.5 metres or thereby

East

From the extended southwest kerb line of the school access road southwestwards for a distance of 2.5 metres or thereby

East

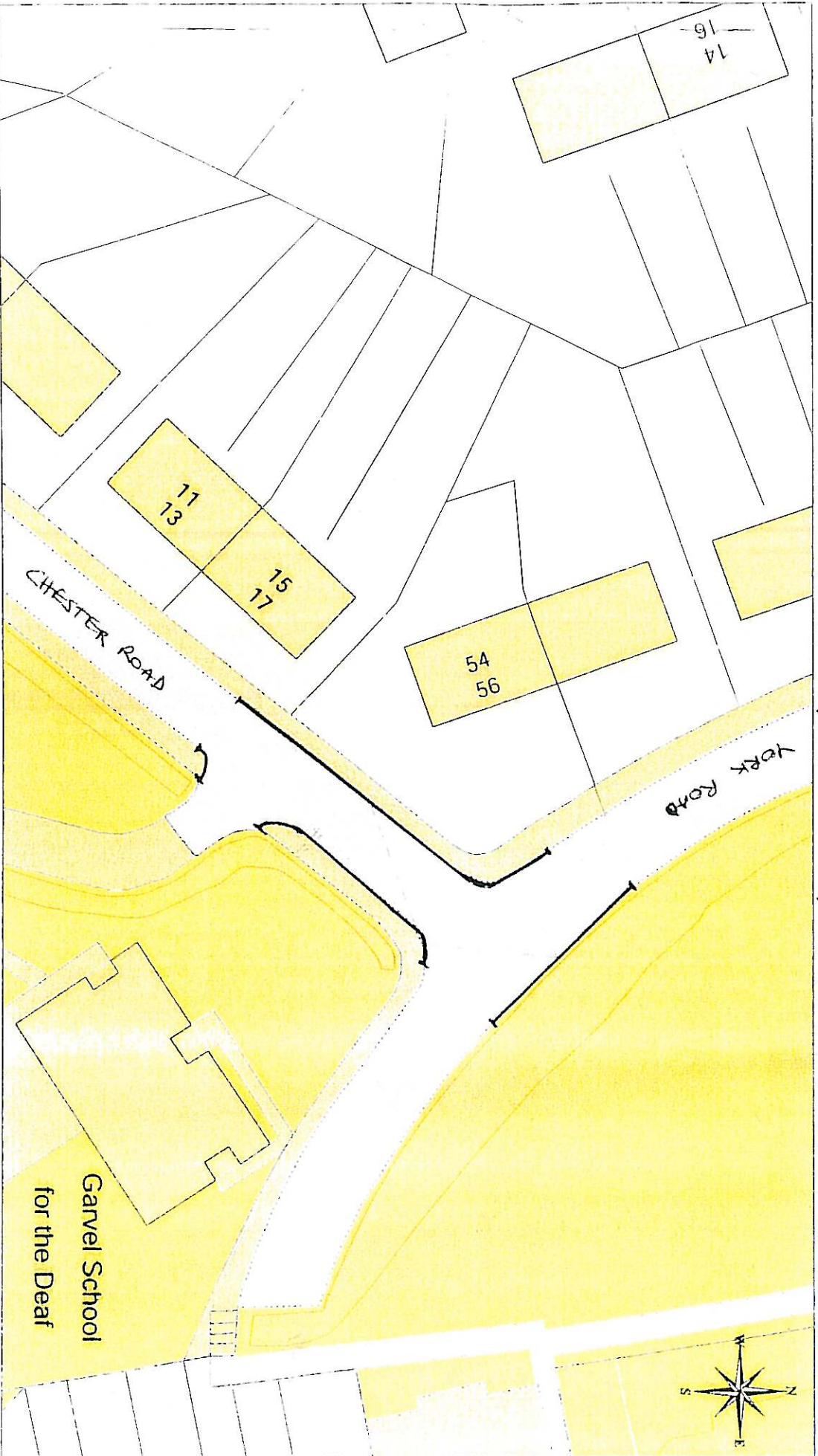
