Subject: Appointment of Leader, Depute Leader and Leader of the Minority Groups
Appointments to Committees and Conveners and Vice-Conveners

1.0 PURPOSE

- 1.1 The purpose of this report is to request the Council to appoint the Leader and Depute Leader of the Council, the Leader of the Minority Groups and to appoint Members to Committees together with Conveners and Vice-Conveners.

2.0 APPOINTMENTS TO COMMITTEES

- 2.1 Paragraph 5.4 of the Scheme of Administration requires the Council to ensure, as far as practicable, that in making appointments to Committees, Sub-Committees and Outside Bodies (but only where more than two representatives of the Council to an Outside Body are required) the balance of political representation on the Council is reflected.
- 2.2 Following the local government elections on 3 May, the political balance of the Council is as follows:-

Labour - 10 Members
SNP - 6 Members
Scottish Liberal Democrats - 2 Members
Scottish Conservative and Unionist - 1 Member
Independent - 1 Member

Appendix 1 sets out the political balance for Committees on the basis of the results of the 3 May election.

3.0 RECOMMENDATION

- 3.1 That the Council appoint the Leader and Depute Leader of the Council and the Leader of the Minority Groups; and
- 3.2 That the Council appoint Members to Committees, Sub-Committees and Regulatory Boards together with Conveners and Vice-Conveners as set out in the schedule attached as Appendix 2.
