## **1.0 PURPOSE**

- 1.1 The purpose of the report is to introduce Traffic Regulation Order – Netherwood Road, Kilmacolm (Weight Restriction Revocation) Order 2013.

## **2.0 SUMMARY**

- 2.1 At the meeting of The Inverclyde Council held on 17 February 2000 the Council agreed to make the Traffic Regulation Order – Netherwood Bridge, Kilmacolm (10 Tonne Weight Restriction) Order 2000. The bridge has been upgraded and the 10 Tonne weight restriction is no longer necessary. Accordingly, it is proposed to revoke the Traffic Regulation Order which imposes the restriction.
- 2.2 The Environment and Regeneration Committee, at the meeting held on 7 March 2013, agreed that The Inverclyde Council be asked to make a Traffic Regulation Order to revoke the 10 Tonne weight restriction on Netherwood Road, Kilmacolm in terms of the Road Traffic Regulation Act 1984, Roads (Scotland) Act 1984 and associated Regulations.
- 2.3 The proposals have been advertised and no objections have been received.

## **3.0 RECOMMENDATION**

- 3.1 That a Resolution is made in the following terms.
- 3.2 THE INVERCLYDE COUNCIL, incorporated under the Local Government etc. (Scotland) Act 1994, RESOLVE TO MAKE as they HEREBY MAKE a Resolution under Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 to permit revocation of the existing 10 Tonne weight restriction on Netherwood Road, Kilmacolm all as detailed in a copy of the Order forming a supplement to the principal minute hereof, and that the Head of Environmental & Commercial Services and Head of Legal & Democratic Services be authorised to take all necessary action in connection therewith. 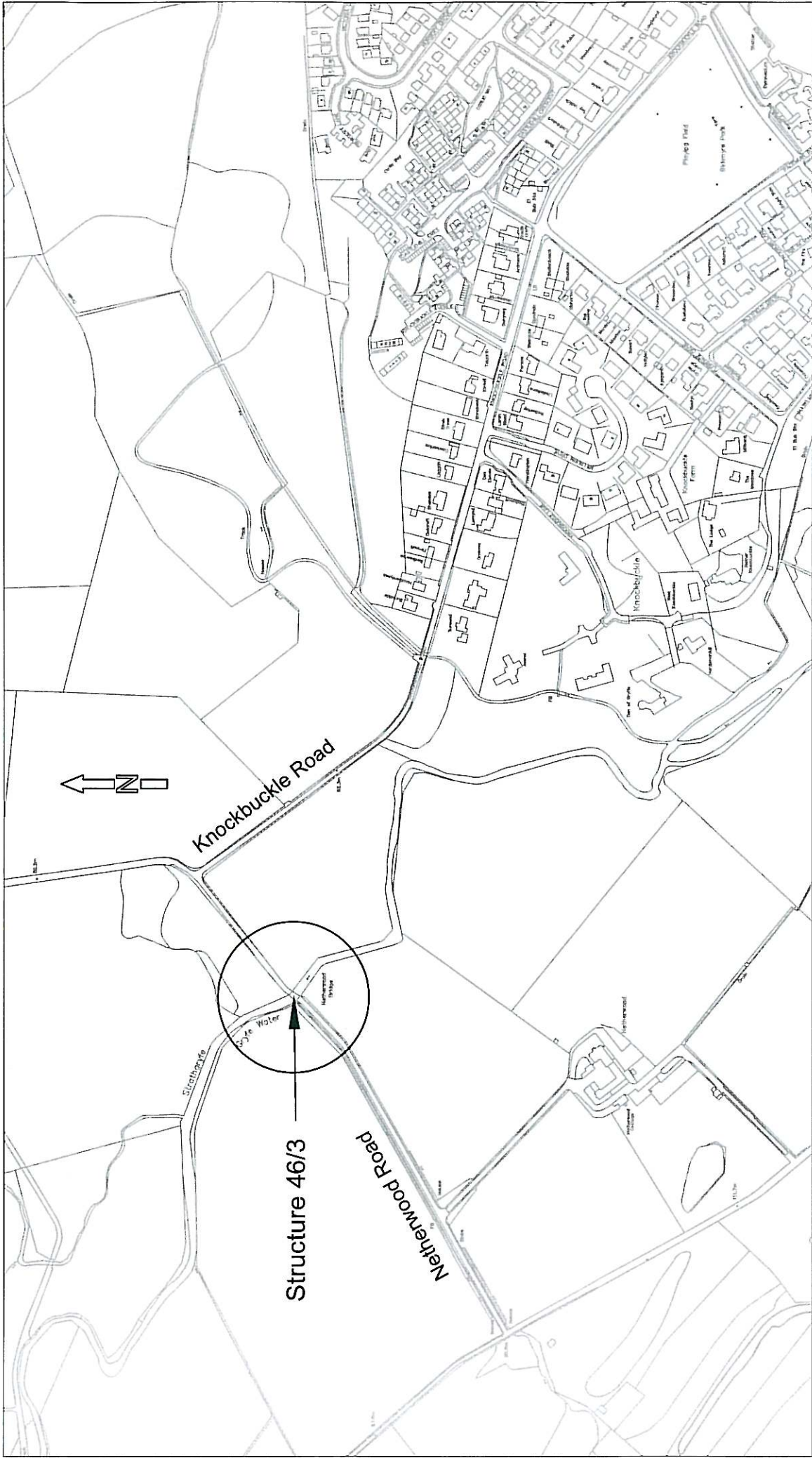
