TAXI FARES REVIEW 2013

1.0 PURPOSE

- 1.1 The purpose of this report is to seek the views of the Board on the annual review of taxi fare scales for the purposes of public advertisement as the first formal stage of the statutory process.
- 1.2 The informal consultation process for this year's review of the taxi fares has been commenced and the Operators Liaison Group and other members of the trade have been invited to submit their view of the level of taxi fares so that any revision of the fare scales will be implemented in November.

2.0 RESPONSE BY TAXI TRADE

2.1 The taxi trade were invited to submit their views on the taxi fare scales and a copy of a APPENDIX 1 letter of response received from Invercive Taxis Ltd setting their submission in detail and their justification for it forms Appendix 1 to this report.

The trade have requested that the General Purposes Board give due consideration to a review of official and unofficial taxi ranks and allocation of spaces. In addition they request that the Board endorse a discount structure to Taxi/Private Hire fees.

The Board may wish to note that these requests will be dealt with as a separate matter from the Taxi Fares Review.

- 2.2 The submissions for change to the tariff scales are:
 - (i) Tariff 1 – increase initial charge to £ 2.50 and 9.89% increase on subsequent charge.
 - Tariff 2 increase initial charge to £ 2.60 and 9.89% on subsequent charge. (ii)
 - (iii) Tariff 3 – increase initial charge to £ 2.80 and 9.89% on subsequent charge.
 - Minimum charge of £ 5.00 on 2 January. (iv)

3.0 COMMENT ON THE PROPOSALS FROM THE TRADE

3.1 The Head of Environmental & Commercial Services was invited to submit his views on the taxi fare scales and his comments are as follows.

The Head of Environmental & Commercial Services has commented that collectively the groups have cited increased running and living costs since the last fare increase in November 2012 as justification for their proposals to be considered.

Fuel costs for diesel has fallen by approximately 1.8%, if comparing November 2012 prices with the June 2013 prices (source; AA Fuel Price Report), but that is simply a snapshot of prices at two fixed periods in time. Fuel prices have fluctuated greatly over this period and the Head of Environmental & Commercial Services feels a more realistic indicator to use would be the Consumer Price Index (CPI) which takes into account all the areas highlighted as inflationary pressures by the groups. The CPI is the measure adopted by the Government for its UK inflation target. Over the one year period from June 2012 to May 2013 the CPI annual inflation rate stands at 2.7% (source; Office for National Statistics).

The proposals submitted by the trade equate to increases of:

These are difficult economic times for all sectors of the community which form the customer base for the taxi industry, and the tariff increase should reflect the levels of wage rises seen in other sectors. Average wage rises in the Public and Private Sectors from March 2012 to March 2013 stood at 1.1% (source; Office for National Statistics).

Two illustrations below show alternative tariff increases in percentage terms.

Illustration 1

A 10 pence increase in the flag fall across Tariff's 1, 2 and 3 for the first 1004 yards on Tariff 1 and first 974 yards on Tariff's 2 and 3 as per existing distances, with no reduction in yardage thereafter would equate to an increase of:

A 10 pence increase in the flag fall across Tariff's 1, 2 and 3 for the first 1004 yards on Tariff 1 and first 974 yards on Tariff's 2 and 3 as per existing distances, combined with a 5% reduction in yardage thereafter would equate to an increase of:

3.2 The Head of Environmental & Commercial Services has also made comment in respect of the review of taxi ranks and would invite representations of the trade in respect of areas of over and under capacity at specific times to assist in the review of official taxi ranks. The Head of Environmental & Commercial Services is willing to engage with both the trade and the Police to carry out a robust review of taxi ranks.

4.0 EXISTING FARE SCALES AND CHARGES

4.1 Appendix 2 to this report details the current fare scales and the proposals submitted by APPENDIX 2 Inverciyde Taxis Ltd and the Head of Environmental & Commercial Services which would apply if the proposals described were adopted provisionally for the purposes of advertisement.

5.0 CONCLUSION

5.1 That the Board consider the proposals for the review of taxi fares and charges and remit it to the Head of Legal & Democratic Services to advertise the proposals they determine and report on the outcome once the statutory period for representations has lapsed.

Re: Taxi Fare Review 2013

In answer to your correspondence dated 5th June 2013, I have much pleasure in responding accordingly on behalf of Inverciyde Taxis Ltd, ABC Taxis (Inverciyde) Ltd and associated Operators Liaison Group (hereinafter called ITL, ABC and OLG respectively) regarding the proposed Taxi Fare Review 2013.

Commercially, market forces (i.e. the purchase of vehicles has increased significantly since the last fare increase on 25th November 2012, Inverclyde Council charges & fees over the last three years, increased fuel costs, insurance premiums, food & utilities, maintenance / repair costs, tyres, credit restrictions, etc) are dictating disturbing trends, which has resulted in a significant increase in an operators cost per mile, particularly MAV's.

ITL, ABC and OLG remain extremely conscious and mindful of the current challenging times being experienced by all sectors of the community, including the taxi trade, and confirm the overwhelming consensus amongst operators and drivers alike is that the trade would welcome full endorsement for the following proposals by the General Purposes Board.

We, ITL, ABC and OLG would therefore respectively request that the General Purposes Board give due consideration and endorse the following proposals: -

- 1. Tariff 1 flag fall to go up to £2.50, and propose a 9.89% increase after 1,004 yards.
- 2. Tariff 2 flag fall to go up to £2.60, and propose a 9.89% increase after 974 yards.
- 3. Tariff 3 flag fall to go up to £2.80, and propose a 9.89% increase after 974 yards.
- 4. We are in no doubt the General Purposes Board would acknowledge that operators / drivers do incur a high portion of unsocial hours by having to work weekends and public holidays, and would therefore ask the Board members to endorse a minimum charge on 2nd January of £5.00.

- 5. We would ask that the GPB members endorse a discount structure similar to that of our neighbouring Councils to Taxi / Private Hire Fess for payment in advance (e.g. 2/3-years fees paid in advance subject to an agreed discount structure), as this would ease the financial / administration burden on Invercive Council resources and operators alike.
- 6. As we continue to strive for continuous improvements in maintaining a high level of customer service, we would respectively request that the General Purposes Board give due consideration to a full and transparent review of official / unofficial taxi ranks and allocation of spaces, as the status quo is causing a degree of confusion and unnecessary inconveniences for the Council, Police and trade.
 - It should be acknowledged that it has been some years since a review of taxi ranks and allocation of spaces has been conducted, hence this request as there has been significant changes in customer demands in relation to preferred pick-up points.
- 7. We would also welcome further synergy in relation the allocation of recognised holidays by having the 15th April (Local Spring Holiday) changed to Easter Monday, as the proposed change is an acknowledged holiday by the vast majority of the local community.

Indications from respected economists is that the UK is likely to experience further economic turbulence, resulting in further increases in the cost of vehicles, fuel, insurance premiums, maintenance, etc, hence we would respectively request that GPB give due consideration to endorsing a mid-term fare review should the economic climate have a significant detrimental impact on operating costs.

Furthermore, we would also request that Inverciyde Council and GPB members give due consideration to refraining from approving any inflationary increases given the exorbitant increases applied in 2011 and 2012, whilst bearing in mind the diminishing employment opportunities and declining disposable income in Inverciyde.

You will no doubt acknowledge our submission is accruing for many factors that affect the community, whilst also attempting to sustain a credible income for operators and drivers, as Inverclyde Council Fares and Charges currently reside in 26th place within the Local Authority structure in Scotland.
