TAXI FARES REVIEW 2014

1.0 PURPOSE

1.1 The purpose of this report is to ask the Board to determine the taxi fare scales and charges following the annual review.

1.2 At its meeting on 13 August 2014, the Board considered the results of the informal consultations carried out as to what changes, if any, were required in the existing taxi fare scales. The Board adopted a preliminary view and this report advises of the results of the statutory consultation exercise.

2.0 RESULT OF CONSULTATIONS

2.1 At its meeting in August, the Board, following consideration, decided to adopt the scale **APPENDIX 1** of taxi fares and other charges set out in the tariff card Appendix 1 to this report.

- 2.2 Members are asked to note that the costings for the first and additional miles in each tariff are described as <u>approximate</u> and should not be seen as an essential part of the fare scales.
- 2.3 It should be noted, further, that the tariffs set out by the local authority are the maximum fares that may be charged by the operators of taxis within Inverclyde.
- 2.4 The proposed taxi fare scales and charges were duly advertised and objections and representations were to be received within the statutory period of one month following the date of advertisement. No objections or representations were received.
- 2.5 Subject to any appeal against the decision by the Council as licensing authority, it is proposed that arrangements be made for the fare scales to take effect from Sunday 23 November 2014.
- 2.6 The change in taxi meters would be carried out by the normal complement of 3 Council staff and with the assistance of a representative of the electronic meter company.

3.0 RECOMMENDATIONS

3.1 That the Board determine the taxi fare scales and charges following the annual review and that it be remitted to the Head of Legal & Property Services to make the necessary arrangements to implement the new taxi fare scales.
