Subject: PROPOSED TRAFFIC REGULATION ORDER – THE INVERCLYDE COUNCIL (VARIOUS ROADS) (INNER GREENOCK) (CONTROLLED PARKING ZONE) (VARIATION NO. 3) ORDER 2015

1.0 PURPOSE

- 1.1 Local Authorities are empowered to make Orders under the Road Traffic Regulation Act 1984 as amended and under the Council's Scheme of Administration the Head of Environmental and Commercial Services is responsible for the making, implementation and review of Traffic Management Orders and Traffic Regulation Orders.
- 1.2 The purpose of the report is to introduce the Traffic Regulation Order – The Inverclyde Council (Various Roads) (Inner Greenock) (Controlled Parking Zone) (Variation No. 3) Order 2015.

2.0 SUMMARY

- 2.1 During the promotion of another proposed Traffic Regulation Order, The Inverclyde Council (Various Roads) (Outer Greenock) (Waiting Restrictions) (Variation No. 3) Order 2014, a concession was made to a Town Centre trader in order to secure the withdrawal of his objection to that Order, which concession resulted in the proposal to remove Jamaica Street (from West Stewart Street and Union Street) from the Outer Greenock Zone, re-introduce Jamaica Street (from West Stewart Street and Union Street) to the Inner Greenock Controlled Parking Zone and introduce revised on-street limited waiting restrictions.
- 2.2 The proposed Traffic Regulation Order will have the effect of including Jamaica Street (from West Stewart Street to Union Street) in the Inner Greenock Controlled Parking Zone and introducing the following revised on-street limited waiting restrictions, all in accordance with the map forming Schedule 1 of the proposed Order, a copy of which is appended hereto:-
 - On-street 'Limited waiting Mon-Fri, 8am-6pm, maximum stay 2 hours, no return within 30 minutes' restriction on the north side of Jamaica Street (between West Stewart Street and Union Street) and on the south side of Jamaica Street (between West Stewart Street and Jamaica Lane);
 - On-street "Limited waiting Mon-Sat, 7am-6pm" on a section of the south side of Jamaica Street (between Union Street and West Stewart Street); and
 - "No waiting at any time, No loading at any time" restrictions at the entrances to Jamaica Lane and two private accesses off Jamaica Street (between West Stewart Street and Union Street).

2.3 Authority to proceed to promote the proposed Order was provided by the Environment & Regeneration Committee at its meeting held on 4 December 2014.

3.0 **RECOMMENDATION**

3.1 That the Committee recommend to The Inverclyde Council the making of the Traffic Regulation Order – The Inverclyde Council (Various Roads) (Inner Greenock) (Controlled Parking Zone) (Variation No. 3) Order 2015 and remit it to the Head of Environmental and Commercial Services and Head of Legal and Property Services to arrange for its implementation.

4.0 BACKGROUND

- 4.1 The existing Traffic Regulation Order currently in force in Jamaica Street (from West Stewart Street to Union Street) is The Inverclyde Council (Various Roads) (Inner Greenock) (Controlled Parking Zone) Order 2013.
- 4.2 The Council is currently promoting another Traffic Regulation Variation Order, The Inverclyde Council (Various Roads) (Outer Greenock) (Waiting Restrictions) (Variation No. 3) Order 2014 (referred to at Clause 2.1 of this Report) which will have the effect of including Jamaica Street (from West Stewart Street to Union Street) in the Outer Greenock Zone.
- 4.3 The Council is currently promoting a further Traffic Regulation Variation Order, The Inverclyde Council (Various Roads) (Outer Greenock) (Waiting Restrictions) (Variation No. 4) Order 2015, which will have the effect of removing Jamaica Street (from West Stewart Street to Union Street) from the Outer Greenock Zone.
- 4.4 The proposed Traffic Regulation Order will have the effect of once again including Jamaica Street (from West Stewart Street to Union Street) in the Inner Greenock Controlled Parking Zone and introducing revised on-street limited waiting restrictions, all as more fully detailed at Clause 2.2 of this Report.
- 4.5 No objections have been received to the proposed Order.
- 4.6 The Committee is asked to note that, if approved, the Order may not be implemented until the making of the Order has been advertised to allow any persons who so wish a period of six weeks to question the validity of the Order in terms of the Road Traffic Regulation Act 1984.

We, The Inverclyde Council in exercise of the powers conferred on us by Sections 1(1), 2(1) to (3), 4(2), 32(1), 35(1), 45, 46, 49, 53, 101 and 102 of the Road Traffic Regulation Act 1984 (as amended) ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consulting the Chief Constable of the Police Service of Scotland (Seirbheis Phoilis na h-Alba) in accordance with Part III of Schedule 9 to the Act hereby make the following Order:

1.0 Commencement and citation

1.1 This Order shall come into operation on the ** day of **, Two thousand and ** and may be cited as "The Inverclyde Council (Various Roads) (Inner Greenock) (Controlled Parking Zone) (Variation No. 3) Order 2015".

2.0 Interpretation

2.1 Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

2.2 Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, modified, re-enacted, replaced or supplemented by any subsequent enactment.

2.3 The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment provided that where a prohibition or restriction which is imposed, varied or revoked by this Order is in conflict with a prohibition or restriction imposed by a previous Order, then the provision of this Order shall prevail.

2.4 The On-Street Plans forming Schedule 1 to this Order and titled "The Inverclyde Council (Various Roads) (Inner Greenock) (Controlled Parking Zone) (Variation No. 3) Order 2015 On-Street Plans" are hereby incorporated into The Inverclyde Council (Various Roads) (Inner Greenock) (Controlled Parking Zone) Order 2013 and recorded in "The Inverclyde Council (Various Roads) (Inner Greenock) (Controlled Parking Zone) Order 2013 Plan Index".

2.5 The Plan Index forms Schedule 2.

2.6 The Interpretation Act 1978 (as amended) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
