

1.0 PURPOSE

1.1 The purpose of this report is to give details of applications received for consideration for funding from the Community Facilities Fund Budget in 2015-2016.

2.0 SUMMARY

- 2.1 The remaining budget for the Community Facilities Fund for 2015-2016 is £134,000.
- 2.2 Details of the grant applications received are given in Appendix A. In total, 3 grant applications have been received with the total sum requested being £32,812.30.
- 2.3 To assist the Grants Sub-Committee, Officers have made recommendations within the budget available.
