## 1.0 PURPOSE

1.1 The purpose of this report is to give details of the application which missed being brought forward for consideration for funding from the Grants to Voluntary Organisations Budget in 2016-2017.

## 2.0 SUMMARY

- 2.1 The budget for the Grants to Voluntary Organisations Fund for 2016-2017 is £325,590. From this amount £190,161 has been set aside to support the third year of funding for the 3 year grants awarded in the financial year 2014-2015, leaving £135,429 available for Round 1.
- 2.2 One application from a local art class has been received with the total sum requested being £1,920. Details of the grant application received are given in Appendix A.
- 2.3 Members are invited to determine the final grant to be awarded to the application as detailed in the appendix, having regard to Officer's recommendations and the total funds available.
