704 Clune Park Estate

There was submitted a report by the Head of Legal & Property Services on the recent judgement relative to the six Clune Park Demolition Order Appeals and setting out the intended future progress providing (1) a detailed appraisal of the actions of the Officers and the external parties involved in supporting the Council's aims, (2) an assessment of the implications of the Sheriff's judgement and subsequent findings and (3) the recommended next steps in the Council's action.

Decided:

(2) that it be remitted to the Corporate Director Education, Communities & Organisational Development to continue with the course of action set out in Section 14 of the report, including the service of appropriate Statutory Notices, all in consultation with the Head of Legal & Property Services;

(4) that if any formal legal offer to convey the properties within the Clune Park Estate is received by the Council, a report thereon be submitted to the Education & Communities Committee at the earliest opportunity but that, in the meantime, the actions decided in terms of (2) above be pursued; and

(5) that Officers engage with the Scottish Government to (a) discuss the implications of the recent judgement on the implementation by local authorities of their statutory powers relative to housing legislation and area renewal and (b) seek any financial assistance that may be available to the Council for the regeneration of the Clune Park Estate.
